Treasurer’s Report

Treasurer Getty updated the Trustees on the health of TTO staff and their families since the last meeting and in relations to the Covid-19 pandemic. Treasurer Getty commended the TTO staff for continuing to meet the needs of member districts despite recent power outages. Additionally, Treasurer Getty noted that the State had issued funding very promptly ahead of the 2020-2021 school year but there has been no information regarding the status of additional funding under the CARES Act. The TTO audit is underway and the office is on track to complete it and issue report ahead of last year. The transition to the TTO’s new IT vendor is complete and going well.

Quarterly Investment Report – June 30, 2020

The Lyons Township Treasurer Office's total investment portfolio continues to outperform its benchmark (Bank of America Merrill Lynch 1-10 Year Treasury & Agency Index) with 13.00% higher returns (LTTO: 3.149% vs. BOA ML 1-10 Index: 2.787%) in the fourth quarter of FY2020. The FY2020 investment income distribution totaled \$5.05 million, a \$185,000 increase over FY2019 (\$4.865 million). Treasurer Getty will post the updated investment report on the TTO website and send out to member districts

OLD BUSINESS:

Pro-Rata Receivables - FY2019

Treasurer Getty provided an update on the FY2019 Pro-rata receivables. All payments have been received, with the except of District 217 and a partial payment by District 204.

Cook County Tax Distribution – FY2021

The TTO is closely monitoring the current tax collection/distribution of the second installment of 2019 property tax collections by the Cook County Treasurer's Office. As of the end of August 2020 we are seeing an approximate 11% or \$22 million year-over-year decrease in tax distributions as of the date of this meeting. There is one additional distribution due this month and this information will be sent to all member districts.

Lyons Township Municipal Liquidity Facility

This program is being developed to provide cash flow support to member districts and/or other municipal agencies within Lyons Township by making approximately \$15-\$25MM of funds from the TTO's short term investment portfolio available to purchase tax anticipation

warrants or other investment instruments from these agencies. This will provide a safe investment for the TTO and potentially reduce the issuance and/or interest cost for participating agencies. The TTO expects to be ready to go to market with the program later this Fall.

District 204 Litigation Update

Trail dates have been set for 11/9/20, 11/10/2020, 11/12/20, 11/16/2020 and 11/17/2020 via Zoom. Zoom will allow for maximum participation from member districts and the public. All filings are current and available on the TTO’s public website. The Trustees remain willing to participate in settlement discussions.



The Trustees discussed the status of pending litigation.


