Application Details

- Complete and **send your application (the address is listed on the application page.)** **Enclose** your check for booth space. Booth rental is \$35 and with electricity \$45.
- Application **deadline is June 5, 2021.** Applications received after that date, will be accepted, based on space availability.
- **New vendors:** If this is your first time vending at the Winery, please attach 2-3 photos in .JPG format along with a brief description of your work and email to debk@richwoodwinery.com.
- All accepted applicants will be notified via email or mail within a week upon receiving your application.
- **Setup time:** Saturday, June 19, 10:00 am – 1:30 pm.
- Booth spaces are approximately 10 feet by 10 feet and vendors are responsible for their own table and canopy. Please allow for social distancing in your booth as much as possible!
- Food vendors must provide a food handlers license.
- No vendor will be allowed to sell or give away beverages of any kind without prior permission.

Please note this is a rain or shine event. All Vendors are required to supply their own booth(s) and tent(s). It is strongly recommended Vendors set up their own canopy for protection from inclement weather because this is an outdoor show. Richwood Winery is not responsible for providing any shelter or protection, nor liable for any loss or damage. Each Vendor setting up a booth agrees to hold Richwood Winery and its owners harmless from any and all types of liability. All Vendors are responsible for collecting Minnesota sales tax.
