### **HOAANNUAL MEETING**

#### WINTER/SPRING ROUNDUP AND CHANGES TO COME

If you have lived in Barrington Place for any period of time you know that the weather is unpredictable. In December, Winter Storm Elliot chased away those high 70 and low 80-degree days with its arrival just before Christmas, leaving its share of frozen pipes. Fortunately, the only casualty to the HOA was an exterior pipe at the pool pumphouse that broke, but the damage was minimal compared to Winter Storm URI. Lessons learned 2 years ago at the clubhouse paid off on this occasion. But just about everyone lost plants and tender vegetation during the prolonged freeze, including those at the HOA entrances.

Barrington Place also had its share of Christmas and Holiday decorations. Many decorations, including religious themes, manger themes, topiary reindeer, oversized Bulbs and Ornaments, decorated trees, inflatable Santa's and Snowmen, and a multitude of flashing and multicolored lights added to the Holiday spirit. Judging was difficult since so many homeowners keep "Upping their displays" from year to year but winners' names are included in this Banner issue.

However, on other fronts the HOA was not so fortunate. With the coming of the New Year, residents celebrate in various ways, some of them using fireworks, and others using graffiti. Over in Summerfield Park in Section 3, idiots set off roman candles and other fireworks on top of bark chips and wood shavings that are used to cushion the play surfaces under the playground equipment. Besides setting fire to the chips and shavings, the sparks from the fireworks also put nearby homes at risk. Not satisfied with the damage done the idiots spray painted the sidewalk. However, a good pressure wash by yours truly, cleaned up the mess left behind. A reminder to all. FIREWORKS ARE NOT PERMITTED IN THE CITY OF SUGAR LAND.

As temperatures bounce back in to the high 70's, it means that Winter foliage that was killed will be cut back. The big change for the homeowners is that the typically used black/white/green trash bags are not accepted by the City anymore. Only clear bags can be used to bag/put out grass clippings/dead plants also known as "green waste". Open containers are allowed too for green waste but for many who use lawn service companies, the only bags that will be picked up are clear bags. Speaking of lawn service companies, if anyone knows of a service that handles subdivisions, please share that information. Our present lawn service company increased its prices by \$150 a month for this year and we would like to add to our vendor lists.

Those warming temperatures also will go higher in June, July and August. In order to lock in a lifeguard company now so that dip the pool can be enjoyed in the Summer, the HOA must hire a lifeguard company now. Prices for the same Lifeguard service have increased by \$5700 over last year. There being a shortage of Lifeguards in the Sugar Land area was not on my HOA Bingo card for 2022, but it is on the 2023 HOA Bingo card. Again, if you know of an up-and-coming Lifeguard company the HOA would like to know to add it to its vendor lists for future consideration.

# **CITY OF SUGAR LAND TRASH CHANGES**

On January16, 2023, bulky waste pickup transitioned to our new on-call service. So, if you are a First Monday of a month household and were planning to have your bulky waste picked up on the First Monday of the Month... don't! Our new flexible approach to bulky waste allows you to schedule 12 bulky waste collections per year - so use it when you need it! After Monday, January 16th, you can request a bulky waste pick up by visiting www.republicservices.com/municipality/sugar-land-tx, via email at sugarland@republicservices.com, or by calling Republic at 713-726-7307. You will also be able to schedule a bulky waste collection in the new Republic Services App that is coming soon! If you like your current once a month pickup, just use one of these methods to schedule your collections for the entire year. Sugar Landers will now also be able to make 12 bulky waste drop-offs at the landfill at no extra cost.

If you choose to bag your green waste, it will now need to be bagged in clear bags after January 16, 2023. That being said, you do not HAVE to bag your green waste. You may also set your green waste out in a personal container!

We're keeping twice a week trash collection as well as once a week green waste and recycling collections! Your green waste and recycling will each fall on one of your service days. - The Barrington Place HOA documents allows three (3) garage sales per year.
- Advertising signs and materials used to publicize your garage sale should be picked up promptly upon completion of your sale.
- All garage sales shall conform to any rules or regulations specified by the City of Sugar Land or Fort Bend County.

# **CENTERPOINT ENERGY STREETLIGHT OUTAGE EASY FIX**

Have you ever passed a streetlight at night on a street in Barrington Place and seen it flicker? Do you lie awake at night because a nearby streetlight's light flashes through your closed blinds or drawn shades and you wonder what can be done about it so you get a good night's sleep? CenterPoint Energy handles the streetlights. You can type in "CenterPoint Energy Report a Street Light Outage" in the web browser. There is a Blue tab that reads "Report a Streetlight Outage" to click on. This will bring you to a screen '*Let's get it fixed! Tell us where to find the broken streetlight*', asking for a nearby address or a street light number. The streetlight poles have a *6 digit number located on the middle of the pole side facing the street*. The top number is the first number. If the number is not legible on the pole, you can type in a nearby address and a map will appear depicting the street lights in the area with correct pole numbers.

Let CenterPoint Energy know the problem and you will get an automated email documenting your report.

### **BEFORE STARTING AN IMPROVEMENT**

If you are making any type of improvement to the exterior of your home, you must submit a Request For Home Improvement Approval "RFHIA" to MASC Austin Properties, Inc. before starting the work. (This includes painting the exterior, room additions, and replacement of the roof, driveway and fence, etc.)

You can find the required form on our website at www.barringtonplace.net under DOCUMENTS- Request For Home Improvement Approval.

Please make sure to submit the form with the necessary information and as much detail as possible along with samples for a quicker response.

### FOR NOW, KEEPING LIVE CHICKENS AND FOWL IS NOT ALLOWED IN BARRINGTON PLACE

Right now, fresh eggs are a costly item. A dozen eggs cost about twice what it did last year due to an outbreak of bird flu killing many egg-laying hens, along with higher feed and energy costs. Yet for those who love their eggs and want an economical supply, there have been increasing reports of Homeowners keeping chickens and other assorted Fowl in their yards in BPHOA. THIS IS NOT ALLOWED. For early risers, the morning "cock-a-doodle-doo" of the Rooster may seem like music to your ears, but for those who would like to sleep in, hearing a Rooster crowing at sunrise robs you of that opportunity. Chickens also visit neighboring gardens and love to pull up freshly planted onions while they deposit a fresh mound of unwanted droppings. Every legislative session there have been attempts to pass "Chicken" laws to restrict the City's and HOA's right to regulate poultry. There are bills being submitted in the 88th Regular Legislative session but until those laws pass the Texas Legislature and are signed off on by the Governor, keeping Chickens and fowl is not allowed in the subdivision.

The City of Sugar Land has an ordinance that reads: Sec. 3-18. - Keeping of fowl. https://library.municode.com/tx/sugar land/ordinances/code of ordinances?nodeId=951433

(a) It is unlawful to keep fowl on any property, except that fowl may be allowed to inhabit public lakes or ponds, and private lakes or ponds that are managed and maintained by an organization, company or corporation.

(b)The property owner or organization in control of any lake or pond where fowl are allowed must provide care and maintenance for the fowl and property and must remove or otherwise control any fowl which become a nuisance to the residents of surrounding area or community.

(c) The animal services manager may waive certain requirements of this section in cases involving a scientific program, a nonprofit organization show or humane activity.

# CHICKENS AND FOWL NOT ALLOWED (CONTINUED)

#### (Ord. No. 1722, § 1, 12-16-2008; Ord. No. 2154, § 5, 4-2-2019)

The Declarations for BPHOA also read in Article III, Use Restrictions., Section 10 Animal husbandry. No animals, livestock or poultry of any kind shall be raised, bred or kept on any Lot, except that dogs, cats or other common household pets may be kept, provided that they are not kept, bred or maintained for commercial purposes. No more than two (2) of each species of pet will be permitted on each Lot. If common household pets are kept, they must be confined to a fenced backyard (such fences shall encompass the entire backyard) or within the house. When away from Lot, pet must be on a leash at all times. It is the pet owner's responsibility to keep the Lot clean and free of pet debris.

So until the Texas Legislature changes the law, No Chickens or Ducks in Barrington Place. Do not run "afowl" of the law!
