"We Care" Sign Application Procedures

Please follow the steps below to order / receive "We Care" no trespassing signs:

1) The Application

- a) The application needs to be properly and completely filled out.
- b) Checks should be made payable to North Dade Regional Chamber of Commerce. (Sales tax is included in the price.) Please note it takes approximately 10 business days for your check to be processed and the signs are available. You will be notified when your signs are ready to be picked up. If paying by credit card, cash or money order, your signs may be picked up the same day. Please call in advance to confirm office opening times.
- c) The address of the property (where the sign(s) will be posted) needs to be on the application as well as the affidavit.
- d) There <u>must</u> be a contact name and phone number to notify you when the sign(s) are ready for pick up.

2) The Affidavit

- a) The affidavit needs to be signed by the landlord, tenant and/or an authorized individual representing the property where the sign will be posted and the applicants' signature must be notarized.
- b) The notarized affidavit must be sent or presented to the local Metro Dade and/or City of Miami Police Station in the district where the signs will be posted.
- c) Note: Police officers are usually Notary's of the Public if you take your affidavit to the Police Station, they may notarize it for you at that time. (Do not sign the document unless you are in the presence of the Notary.)

3) The Signs

- a) The aluminum signs are usually available in stock at TheChamber® offices. Please call in advance and we will let you know availability.
- b) The signs will need to be picked up at TheChamber™ offices. We do not mail the signs as they are way too heavy. If you cannot come personally; you might think about sending a courier.

Please contact TheChamber™ offices if you have any uncertainty regarding these directions.
