

WHAT IS A CHILDREN'S ADVOCACY CENTER?

*A community based non-profit organization whose purpose is to improve the way a community responds, investigates, and supports child abuse victims and their families.

*An effective fact-gathering method that will lead to prosecution or swift exoneration in child abuse cases.

*A child friendly facility where children and their families can receive support, information, and intervention services to ease the trauma and help child abuse victims in the healing process.

*A neutral environment for specially trained professionals to come together as a "team" to not cause further undue harm to the alleged child victims and their families through the investigative process.

*A unique public-private partnership allowing individuals to assist and support those professionals charged with this difficult work.

HOW IS THE CAC FUNDED?

A Children's Advocacy Center utilizes available financial resources such as...

*State and federal grant funds, including CACTX monies.

*A matching 50% or more of the budget from local contributions from individuals, foundations, businesses, churches and organizations. (For example, a \$500 sponsorship equals \$1,000 for the agency.)
