Refund of Pre-entries & Class Changes– Pre-entries will be refunded only upon written request received prior to close of pre-entries. No other entry refunds will be granted. No class changes will be made once entries have closed.

Returned Checks Any check returned to our bank will invalidate all entries associated with that check. In addition the person writing the check will be reported to ASCA – No Exceptions. Delta ASF will add a \$30.00 Collection fee to the amount of each returned check. Anyone with a check returned must pay all future Delta ASF event fees in cash.

NO Entry will be accepted from a dog, owner or handler disqualified from any ASCA Program or a person not in good standing with ASCA.

Conformation (all classes split by sex - Order to run Juniors, Non-Regular, Altered, Intact,)

Non Regular: Puppies – 2-4 mo, 4-6 mo, BOBP,

Altered: 6-9, 9-12, 12-15, 15-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red

Intact: 6-9, 9-12, 12- 15, 15-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red

Obedience: Utility B/A, Open B/A/CDX/ODX, Novice B/A, Optional Titting Beginner Novice B/A, Sub Novice – Group sits and downs after individual classes. **Obedience is limited to the first 30 entries per show. No entries will be accepted after 30 dogs. No bitches in season are allowed to participate.**

Rally: Masters C/B/A, Excellent C/B/A, Advanced C/B/A, Novice C/B/A **No bitches in season are allowed to participate. Rally is limited to the first 40 entries per show, no entries will be accepted after 40 dogs.**

OBEDIENCE AWARDS - Ribbons 1st through 4th place, green Q ribbons for scores over 170 or higher.

Rosettes: High in Trial, High Combined, High in Trial Junior, High Scoring Aussie, High Scoring Other Breed

RALLY AWARDS - Ribbons 1st through 4th place, Q ribbons for scores 170 or higher, XQ ribbons for 195 or higher

Rosettes: High Scoring Junior in Trial, Hi Combined Score in Excellent B & Masters B.

Section 8: All dogs six (6) months and older must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned obedience trials. ...Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned obedience trials.

DIRECTIONS;

Take Hwy 99 to Turlock. Exit Fulkerth, turn left (eastbound). The third stop light will be Golden State. Make a right on Golden State and then an immediate right on to North Front. Go approximately 2 blocks and make a right, cross the RR tracks, right on Broadway and enter through back gate.
