## MAGDALENA MUNICIPAL AIRPORT IMPROVEMENTS 2020—RUNWAY SAFETY AREA GRADING (PROJECT)

AUTHORIZING SUBMISSION OF AN APPLICATION FOR AIRPORT AID TO THE FEDERAL AVIATION ADMINISTRATION (FAA) AND AN APPLICATION FOR AIRPORT AID TO THE NEW MEXICO DEPARTMENT OF TRANSPORTATION AVIATION DIVISION (NMAD); OBLIGATION OF MATCHING FUNDS; AND, AUTHORIZATION TO ACCEPT THE RESULTING GRANT OFFERS AND EXECUTION OF CONTRACT DOCUMENTS FOR THE PROJECT

**WHEREAS**, the Village of Magdalena Board of Trustees met upon notice of a duly published meeting at 4:00 P.M. on June 15, 2020 at Village Hall, 108 N. Main Street, Magdalena, New Mexico as required by law; and,

WHEREAS, the Board of Trustees of the Village of Magdalena is applying to the Federal Aviation Administration for ninety percent 90% assistance toward the project through the Airport Improvement Program (AIP) which FAA commitment cannot be formally made until a grant offer is made and accepted, and is applying for assistance from the NMAD, and time is of the essence to secure the FAA and NMAD funding; and,

WHEREAS, the Village of Magdalena is the owner of the Magdalena Municipal Airport, the project is within the Village jurisdiction, and is necessary for the public good and convenience and is to serve the users of the Magdalena Municipal Airport; and,

**WHEREAS**, the Village of Magdalena is committed to the project in accordance and consistent with the regulations and policies governing the FAA - AIP program and the NMAD grant conditions.

**NOW, THEREFORE BE IT RESOLVED** that the Board of Trustees of the Village of Magdalena hereby adopts and approves this Resolution and authorizes the Mayor, Richard Rumpf, to execute all documents related to the project and directs staff to take actions necessary to implement and fund this resolution and project.
