

Legislative Update:

Many little bills, some good, some bad, are receiving attention in preparation for the March 15 funnel deadline. House bill have to survive a Senate Committee and vice versa. In the meantime, here is status for some critical **RSAI Priorities**:

SSA Funding: Governor recommended 2.5%. [HF 2613 SSA](#) sets a 3% increase in the State Cost Per Pupil, approved in the House on Feb. 22 . It's over in the Senate attached to SF 2258 on the Calendar. The Senate's bill has no specified increase, serving as a placeholder. Whenever they decide on an amount, they can pass it, send back to the House (if it's not 3%) or to the Governor (if it is 3%). Contact Senators about budget deadlines, urgency to communicate actual information to taxpayers rather than budgets based on unknown assumptions. RSAI is registered in support of the House bill.

Teacher Pay: Governor's recommendation was \$96 million (\$50,000 for beginning teachers up to 12 years of experience and \$62,000 for teacher with 12 years or more). The Senate's proposal, in [SF 2386](#) AEA Reform, sets minimum teacher pay of \$46,251 (on the Senate Calendar). The House's proposal is a stand-alone policy in [HF 2630](#). The House sets beginning teacher pay at \$47,500 for FY 2025, increasing to \$50,000 for FY 2026, includes an appropriation of \$14 million to raise hourly school employee pay to \$15 an hour, and another \$22 million for districts to use at their discretion to compensate both teachers and hourly employees. All three use the teacher salary supplement (TSS) per pupil to deliver resources to schools to meet the minimums. The House has HF 2630 on the Debate Calendar for March 4. RSAI is registered in support of the House bill and opposed to the Senate's AEA bill including teacher pay.

School Start Date: The House's bill, [HSB 585](#), allows school to start the Monday preceding August 23 if August 23 is a weekday. Passed the House Education Committee on Jan. 30 so survived the funnel. It is still awaiting a new bill number before it can be assigned to the House Calendar. The Governor's Charter School bill, [SF 2368](#), is on the Senate Calendar. This bill changes charter school and open enrollment funding (current year cost per pupil rather than prior year state cost per pupil plus the state costs of TSS, PD, and EICS per pupil all follow students), gives charter schools the right of first refusal for lease or sale of school property. Division III of the bill allows schools to start as early as the Tuesday following the end of the Iowa State Fair. RSAI is opposed to SF 2368. The House version, [HF 2543](#), includes all of the provisions above except for the start date policy. RSAI is opposed to HF 2543, too.

Preschool: [SF 2383](#) Expanded Preschool is on the Senate Calendar, but likely in trouble due to the estimated impact of the bill on the state budget. The bill is phased in over two years, up to 1.0 weighting for students below 185% of the federal poverty level. Contact Senators to support it.

AEA Reform: [HF 2612](#) approved by the House on March 1 significantly addressed many RSAI issues, including reinstatement of operational sharing for AEA's and requirement that special

education services be required from AEAs. The Senate’s changes are in [SF 2386](#). See your RSAI weekly report or check out the [AEA Policy Tracking Comparison Chart](#) to see key differences with the Senate.
