## TOWN OF LINCOLN TOWN BOARD MEETING July 9, 2025

The meeting was called to order by Jason Headson at 6:00 pm. Present were: Jason Headson, Ryan Wilson, Lynne Black, and Tressa Votis. Also present: David Derozier, Steve VanGrinsven, Ed Mullaney, Terry Coughlin and Steve VanGrinsven.

On a motion by Wilson, second by Black and all in favor, the agenda for the evening was approved.

The pledge of allegiance was recited.

On a motion by Black, second by Wilson and all in favor, the consent agenda was approved including minutes of the

On a motion by Wilson, second by Black and all in favor, it was decided to approve the speed limit ordinance after a letter was submitted by FCP roads manager, Todd Mulvey. Jason will email the ordinance to Tressa who will publish in next paper.

Jason presented a proposal for paving Lakeview (up to 6200 feet). On a motion by Wilson, second by Headson and with Black voting No, it was decided to approve the paving quote up to 6200 feet. The board will be looking at the area after tonight's meeting to finalize plan.

Jason presented a request for rezoning. The matter involves changing Ryan Wilson's property from Residential to Mixed Use. On a motion by Black, second by Headson and Wilson-abstaining, the request was approved. Ryan will return the paperwork to the courthouse.

Jason brought up the idea of the Town entering the Wisconsin Statement System. Tressa mentioned that January 1 would be the only option to begin the program. Further discussion to take place in August. Jason will request the packet from the state.

Ryan Wilson has submitted a letter of resignation from the Town Board effective July 27, 2025. Tressa stated she is interested in switching roles and is hoping that Deputy Diane Dubey would be interested in the clerk/treasurer position.

UPDATE: Jason mentioned FCP would be potentially be paying for some shoulder grave; the road crew is reporting that Potawatomi Trail is taking a beating with the detour.

Tressa presented the June Treasurer's Report.

Correspondence: Two complaints on roads (Berry Lane/Bradley & Star Lake Rd)

Citizen's Comments: Terry Coughlin brought up the wake-boat ordinance-he asked if the Board needs more information. After discussion, Lynne will try to set something up for the next WTA meeting. Terry also mentioned the boat landing is a mess-Jason stated it's not the town's responsibly.

On a motion by Wilson, second by Black and all in favor, the meeting was adjourned at 7:06 PM to go look at Lakeview Ave. Meeting officially adjourned at 7:22 PM.
