- 10. 70% of entry fee & 100% of added money will be jackpotted. All nomination fees and payments will be included in payout. Two go's and an average will be paid in the Futurity: 60% to 1D, 40% to 2D. (1st go 30%, 2nd go 30%, Average 40%).

- 17. Ground will be raked every 5 runners with a tractor and big drags will be determined. Horses will not be worked on markers, barrels are not allowed in the arena during open ride or any other time June 18th-21st 2020 except during time only.
