

-ACKNOWLEDGMENT OF RISKS AND WAIVER OF LIABILITY

In consideration of the services of USA STARS EAST, LLC, their officers, agents, employees, and members, and all other persons or entities associated with those businesses (hereinafter collectively referred to as "USA Stars East"), I agree as follows:

Although USA Stars East has taken reasonable steps to provide me with appropriate equipment and instruction so I can enjoy an activity for which I may not be skilled, USA Stars East has informed me that Judo is not without risk. Certain risks are inherent in Judo and cannot be eliminated. These inherent risks are some of the same elements that contribute to the unique character of Judo and can be the cause of accidental injury, illness or in extreme cases, permanent trauma or death. USA Stars East does not want to frighten me or reduce my enthusiasm for Judo, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks: Bruising; Sprained tendons and/or ligaments; Broken bones; Collisions with other Judo participants; Limitations in my physical condition; Loss of consciousness; Negligence of USA Stars East or its agents, officers, employees, or representatives.

I am aware that Judo entails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in Judo is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different from other activities and that I have responsibilities as a participant. I acknowledge that the staff of USA Stars East has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death, or loss of personal property and expenses as a result of those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.

I have carefully read, do clearly understand, and do hereby accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me, my heirs, assigns, personal representatives, and for all members of my family, including minor children. I am not relying on any oral, written, or visual representations or statements made by USA Stars East, including those made in its brochures or promotional materials, to induce me to participate in this activity.

This waiver shall remain valid unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by the USA Stars East.

With the knowledge of the foregoing, and as an inducement for USA Stars East to allow me to train in Judo with the Club, I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against the Club or any members of its Board of Directors, employees and participants, arising from any damages, injury, or death which I might sustain or which might occur to any participant I am training with as a result of my participation. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from training with the Club. Furthermore, I agree to indemnify the Club, its Board of Directors, members or employees, or any landowners, their families, employees or tenants, for any injury, death, loss, or damage to any personal property which might occur during my participation in Judo.
