c. Report from Board members who attended the July AFCA Conference. Overall good conference.

Brian: met with Chief and Battalion Chief re: legal lessons

Policies, review policies regularly, document, document, document.

CRR community risk reduction.> what should BRFD be doing and is BRFD taking action

LA County Fire Chief>3000 firefighters were ready to go and still couldn't stop Palisades Fire.

Face reality = People refuse to evacuate—provide some training and support for them.

Linda: BRFD is proactive in comparison. Risk reduction might include a safe zone around properties. Marketing, recruitment, medical needs in rural communities, AI

Casey: LA County Fire Chief> Again, overwhelmed. Retired Fire Chiefs> Things have changed: more medical than fire prevention; how can BRFD be more proactive, e.g. a health fair? Coconino County Health, Firewise push and enforcement in all communities
