PDP LOUISE O'DONNELL MEMORIAL AUXILIARY #1 "WOMAN OF THE YEAR" AWARD – (Presented by Auxiliary #1) (Individual) doing the most service to further the Aims & Purposes of AMVETS Ladies Auxiliary.

AUXILIARY OF THE YEAR SERVICE AWARD- (Auxiliary) reporting the most service work (percentage per member) to the Department Service Chairmen.
(Total auxiliary service evaluations divided by the total members)

PDP VIRGINIA (GINNY) MARTIN MEMORIAL LOCAL GOOD SAMARITAN AWARD- (IN HONOR OF PDC AL WOODARD)- (Presented by Auxiliary #15) (Auxiliary) who has supported its Post above and beyond the call of being a helper.

PNP EVELYN R. McELVIN PRESIDENT'S GREEN HAT AWARD- (Individual) Local green hat member who has gone above and beyond the call of duty to assist the President.

PDP ESTRELLA YOUNG HONORARY MEMBER OF THE YEAR AWARD – (Individual) Awarded to the individual Honorary Member who has done the most to assist the local auxiliary with furthering the Aims and Purposes of AMVETS Ladies Auxiliary.

PNP ANNE E. HALL MEMORIAL SCRAPBOOK AWARD- (Auxiliary) preparing the best scrapbook following the criteria. PNP RUTH K. NICKERSON MEMORIAL MEMBERSHIP AWARD (Chairman) Largest number of renewals.

PDP LUCILLE T. HENSON AWARD- (Individual) Collecting the most money for John Tracy Clinic.

PDP DORIS A. MILLER MEMORIAL CHILD WELFARE AWARD-(Presented by Aux. # 30) (Individual) Doing the most child welfare service.

CHILD WELFARE SERVICE CHAIRMAN AWARD- (Individual) Demonstrating ability in forming committees to successfully complete projects and forward reports promptly to Department Chairman.

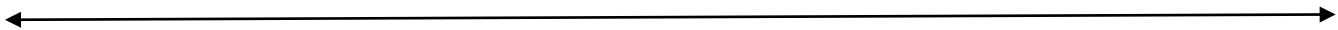
PDP DELIA J. RAY MEMORIAL HOSPITAL AWARD- (Auxiliary) with the highest hospital totals including hours, money, and donations.
