**RESOLUTION NO: SL – 46 - 2023**

**TITLE:** Accepting application for enrollment of **Rene Junior Guzman Jr.** a Summit Lake Paiute Tribal Member

**WHEREAS,** the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council (see Article II, Section 1) to include establishing a membership (see Section 1 (h)s of procedure (see Section 1 (j)), and to take such actions as are necessary to carry into effect any of the foregoing power and duties (see Section 1 (k)); and,

**WHEREAS,** the Articles of Association of the Summit Lake Paiute Tribe, Nevada (hereinafter Articles of Association), Article III, Section 1 prescribes eligibility requirements to be a member of the Summit Lake Paiute Tribe, and Section 1 (c) Lineal Descendants of all persons in the above categories; and,

**WHEREAS,** the Summit Lake Paiute Tribe’s Articles of Association grant the Summit Lake Paiute Council (see Article II, Section 1) certain sovereign powers, including the power, in accordance with the Articles of Association (see Articles III) and the Tribe’s Enrollment Ordinance (see Articles III) to decide who is a member of the Tribe; and,

**WHEREAS,** on **November 17, 2023**, the Enrollment Committee recommended approval of **Rene Junior Guzman Jr.’s** application for membership; and,

**WHEREAS,** the Tribe’s Enrollment Ordinance, Article III, Section 5(a) states a Resolution “shall state: the applicants name, the date of the applicant’s birth and that the requirements for membership have been established”; and,

**WHEREAS,** the Tribe’s Enrollment Ordinance, Article III, Section 6(c), requires the Council to issue written notice, using Certified Mail with postage fully prepaid and a return receipt required, that the application was approved, providing the Resolution Number and the date of its enactment; and,

**WHEREAS**, the Applicant **Rene Junior Guzman Jr.** has a date of birth of **August 26, 2001**, and all the requirements for membership have been established,

**NOW THEREFORE BE IT RESOLVED**, that the Summit Lake Paiute Council, hereby on this date **November 18, 2023**, accepts **Rene Junior Guzman Jr.** as a member of the Summit Lake Paiute Tribe and assigns him Enrollment Number **236**
