6. CEO: 2024 REVIEW & 2025 FORECAST

• Static monthly costs are over \$30,000

- Static annual costs are around \$360,000
- About \$52,000/year comes from the state allocation
- \$50,000/year comes from the county, and we should get yearly COLA increases beginning in 2026
- AB 1499 money should be about \$100,000 and comes from sales tax initiated on California Fairgrounds
- We try to make up for the deficit through membership, fundraisers and donations, but as you can see there is over \$250,000 that must be raised just to meet the hard costs
- Carrie has been working with Wyn Partners, a Grant Writing Company that specializes in Federal Grants
- So far, we have been awarded \$142,000 to create an Emergency Action Plan EAP
- We are waiting to hear on an additional grant for \$250,000 to implement the EAP

7. COMMITTEE CHAIR PRESENTATIONS:

a. Jr. Livestock, Krista Hymas

There are 20 voting members of the JLA subcommittee. They supervise and assist FFA, 4-H and independents. They help with showmanship and the weigh-in process. They run the auction which is the top selling JL Auction in the state. They help find breeders. Sellers are required to keep records, and statistics while raising their animals. They assist with the Junior Livestock Show and oversee the grand finale, the Auction.

b. Bigfoot Motorsports, Donny Case

2024 went well with many new drivers.

The Enduros pick up with every race and will run 10-15 cars. Drivers come from all over the state. Everyone is important and contributes from the drivers and volunteers to the people I the stands. The goal is to have the Enduro races at least pay for themselves.

The Derby has the biggest purse in California at the smallest Fair. It is a professional sport. Adding the Truck Derby has taken the show to the next level. Donny is working to get the arena set to hold 2000 spectators.

Donny thanks Carrie and the board for supporting the growth of the derby. Carrie said many people in the fair business know who "Derby Donny" is!

c. Equestrian Events, Jerry Hlavac

The creation of the Equestrian committee was to facilitate the riders' use of the fairgrounds. The purpose is to coordinate events, improve the facilities which include the arena and an obstacle challenge course. They have been working on sprinklers, grading and panels. The Trinity Horse and Long-Ears club helps with events. The goals are to increase use, get a Barrel Racing Series going and host gymkhanas and playdays.

d. Fundraising & Sponsorships, Terra Kephart

As Carrie mentioned, fundraising and sponsorships are very important to the success of the association. Terra has challenged each board to bring at least 1 new sponsor to the Fair.

Lots of fundraising events happen. We're thinking about combining Calcutta and Crab Feed this year. Bingo attendance needs to come up. Bunco is traveling to Hayfork businesses to give them a perk. It has been held at Rhonda's so far and is planned to be held at Cali Jays. Bigfoot BBQ will host the Annual all-class reunion this year. Terra would like the association to take over all alcohol sales at
