Whereas, the Position of Superintendent of Public works and Utility Superintendent has been replaced with the Title of Town Manager.


Whereas, the K-9 has been suspended and will not be put on the new Salary Ordinance 2017-15

ORDINANCE FOR ADMENDING ORDINANCE 2013-10  
SALARY ORDINANCE
