16 Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as  
17 follows:

18 1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which  
19 appointed Peter S. Davis as Receiver of DenSco Investment Corporation (“Receivership  
20 Order”).

1           2. Pursuant to *Order Re: Petition No. 1*, the Court approved the Receiver's  
2 compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses  
3 incurred relating to these services as Receiver. These services are billed by and paid to the  
4 Receiver's firm, Simon Consulting, LLC.

5           3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged  
6 the services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and  
7 the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the  
8 services of the firm together with all reasonable costs and expenses incurred on behalf of the  
9 Receiver.

10          4. Pursuant to the Court's *Order Re: Petition No. 2*, the Receiver is authorized to  
11 file this fee petition without including as exhibits the itemization of services rendered to,  
12 and costs incurred or expended on behalf of, the Receivership, provided that the fee petition  
13 includes a statement that anyone desiring additional information concerning the services and  
14 costs to be paid under the fee petition may obtain redacted information from the Receiver by  
15 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a  
16 written request specifying the additional information requested at least three (3) days prior  
17 to the date set for any hearing on the fee petition. The Court's *Order Re: Petition No. 2*  
18 further provides that upon request of the Court, the Receiver shall make available for in  
19 camera review by the Court the itemized statements and supporting documentation for the  
20 services and costs to be paid under the fee petition.

1           5.       The Receiver has submitted an itemized statement for services rendered to this  
2 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable  
3 costs incurred or paid during the period October 1, 2019 through October 31, 2019. The  
4 total amount requested for payment by the Receiver is \$9,385.10. The Receiver believes  
5 that this amount is reasonable and should be paid from the Receivership Assets.

6           6.       The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized  
7 statement for services rendered to this Receivership and for reimbursable costs incurred or  
8 paid during the period from October 1, 2019 through October 31, 2019. The total amount  
9 requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$6,211.90. The  
10 Receiver believes that this amount is reasonable and should be paid from the Receivership  
11 Assets and has therefore approved this statement for payment.

12           WHEREFORE, the Receiver respectfully requests that the Court enter an order  
13 authorizing the Receiver to pay from Receivership Assets:

14           1.       The amount of \$9,385.10 to Simon Consulting, LLC, for services rendered  
15 and costs incurred or paid during the period October 1, 2019 through October 31, 2019; and

16           2.       The amount of \$6,211.90 to Guttilla Murphy Anderson, P.C., for services  
17 rendered and costs incurred or paid during the period October 1, 2019 through  
18 October 31, 2019.
