

# Camp Arrah Wanna, Inc. 2020 Virtual Camp Liability Waiver



We hope you and your campers will join us for “Virtual Camp 2020” here at Camp Arrah Wanna (CAW)!

We will be using Zoom.us, an online video conferencing service, to bring you our interactive camp programs and activities throughout the month of July. This will be a fun and engaging time for our campers, staff, and volunteers!

Before you register your camper, we need to remind parents & guardians that campers will be on a live video conference that may be recorded. Please read through the following guidelines so we can maintain a safe experience for all participants.

1. Your “Camp-In-A-Box” kit will include a schedule of events and instructions on how to join live events. We will also be emailing you a link with instructions on how to join the live Zoom events. You will NOT be required to set up a Zoom account or input any information other than camper’s first name and last initial. Please go to Zoom.us for more details about how the system works.
2. The events will be live and interactive. Please make sure your camper is in a quiet place where a parent/guardian can monitor the session. Please remember that everything within your camera viewing area will be visible to the CAW Facilitator and other campers. Please be aware that online media containing references, ads, or links to materials from third parties may be present during some activities. Camp Arrah Wanna, Inc. is not associated with those third parties.
3. Sound and voices, both quiet and loud, can be captured by your device’s microphone and heard by others in the Zoom session. CAW Facilitators will mute participants for portions of the session but may unmute them during discussions or to hear questions.
4. During live sessions, participants may hear and see anything within the audio and video viewing areas. Please make all household members aware of this. Hanging “Live Video Session” signs around the area or turning the monitor/device camera toward a wall can help with controlling your sound and background.
5. These sessions will be recorded and made available for viewing by campers who were unable to attend that session or for participants to enjoy again at another time.
6. Please discuss responsible and appropriate behavior expectations with your camper before they attend any live events, including but not limited to, respectful language to and for others, their beliefs, and ideas. CAW Facilitators reserve the right to terminate the video and/or audio of any participant at any time should they deem their participation as inappropriate or distracting from the goals of this program.

By submitting the online registration form, you hereby consent to the photography, recording, reproduction or any other manner (including use of video and audiotapes) of the likeness, voice and/or activities of this camper and further authorize Camp Arrah Wanna, Inc. to make copies available to other registered participants.

By submitting the online registration form, you understand that you will not receive any monetary compensation now or in the future for participating. You hereby release and hold harmless Camp Arrah Wanna, Inc., its officers, and employees from any claims.

By submitting the online registration form, you give permission for your camper to participate in the CAW Virtual Camp events using the Zoom video conferencing service. You understand that the live sessions may be recorded and may contain audio & video interactions that include your camper. You understand and agree that in the event any dispute arises between you, either personally or on behalf of your camper, CAW, or their personnel, such dispute will be addressed by the CAW Board of Directors, and decided according to the law of the State of Oregon.

By submitting the online registration form, you acknowledge that you have read this document in its entirety, that you understand its content, meaning, and effect, and that you agree to its terms completely and voluntarily. You also acknowledge by submitting the online registration form, that you accept the allocation of risks and responsibility as between Camp Arrah Wanna, Inc. and yourself and your camper, set forth in this agreement.
