## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.100000 per \$100 valuation has been proposed by the governing body of BEXAR COUNTY EMERGENCY SERVICE DISTRICT No. 10.

PROPOSED TAX RATE	\$0.100000 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for BEXAR COUNTY EMERGENCY SERVICE DISTRICT No. 10 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter approval tax rate is the highest tax rate the BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10 may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10 exceeds the voter approval tax rate for BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10.

The de minimis rate is the rate equal to the sum of the no-new revenue maintenance and operations rate for BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10, the rate will raise \$500,000 and the current debt rate for BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10.

The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate. However, the proposed tax rate exceeds the rate that allows voters to petition for an election under Section 26.075, Tax Code. If BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10 adopts the proposed tax rate, the qualified voters of the BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10 may petition the BEXARCOUNTY EMERGENCY SERVICE DISTRICT NO. 10 to require an election to be held to determine whether to reduce the proposed tax rate. If a majority of voters reject the proposed tax rate, the tax rate of the BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10 will be the voter-approval tax rate of the BEXAR COUNTY EMERGENCY SERVICE DISTRICT NO. 10.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD AT 6658 FM 1346 SAN ANTONIO, TEXAS 78220 ON AUGUST 25, 2025, AT 7:00 PM.

A PUBLIC MEETING ON THE APPROVAL AND ADOPTION OF THE 2025 TAX RATE WILL BE HELD AT 6658 FM 1346, SAN ANTONIO, TX 78220 ON AUGUST 25, 2025, AT 7:00 PM OR FOLLOWING THE CONCLUSION OF THE PUBLIC HEARING.

The proposed tax rate is not greater than the de minimis tax rate. As a result, BEXAR COUNTY EMERGENCY SERVICE DISTRICT No. 10 is not required to hold an election at which voters may accept or reject the proposed tax

rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the BEXAR COUNTY EMERGENCY SERVICE DISTRICT No. 10 at their offices or by attending the public hearing and public meeting mentioned above.
