

Authorization for the Scattering at Sea of Cremated Remains

I the undersigned hereby request and authorize Oceanic West, Inc. (“Oceanic West”) to take possession of and make arrangements for the disposition of the cremated remains of

(Full name of Deceased as recorded on the Death Certificate)

at sea, by vessel, in San Francisco Bay, the Near Coastal Waters of the Pacific Ocean, or in Inland Waters in accordance with and subject to the terms and conditions set forth in this Authorization, Oceanic West policies and procedures, and applicable federal, state and local laws and regulations.

I certify, warrant and represent that I have the full legal right and authority to authorize the disposition of the remains of the Deceased and I understand that once the scattering has taken place, the remains may not be recovered.

Unless otherwise specifically provided for herein, once the scattering at sea has been performed, Oceanic West reserves the right, at its sole discretion, to dispose of the container that contained the cremated remains.

The obligation of Oceanic West shall be limited to the disposition of the cremated remains as directed herein. I agree to release and hold Oceanic West, its affiliates and their agents, employees, successors and assigns harmless from any and all claim, loss, damage, liability or causes of action (including attorney’s fees and expenses of litigation) in connection with the disposition of the cremated remains of the Deceased as authorized herein or with respect to the identification of said remains as being that of the Deceased.

I agree to permit Oceanic West to make an appropriate judgment as to the exact location, time and date of the scattering based on Oceanic West’s expertise with regard to weather or other conditions that may interfere with scattering as specified or preferred by myself or other family members.

Making Arrangements

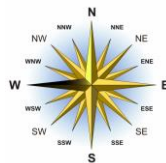
1. If you have any questions at any time, please feel free to call us at 480-272-7780.
2. Unattended Ash Scattering including completing and filing the cremated remains disposition permit with your local Registrar and mailing a Certificate of Scattering at Sea is priced at \$200.00. You may simply follow the Order and Shipping Instructions below to arrange for this.
3. For a Private Attended Scattering, please call us to schedule the time, date and other specific arrangements for your service.
4. Private Attended Scatterings are available on San Francisco Bay, nearby Coastal Waters, or Inland Waters. Please consult with us regarding group sizes, pricing and optional inclusions. Prices include filing paperwork, a basket of rose petals, onboard photography and a digital photo album and Certificate of Scattering. Harbor fees and gratuities are additional.
5. Additional services (ceremony by Captain, extended cruising, food and beverage services, dove release, bagpiper, etc.) are available on request.

Unattended Scattering Order and Shipping Instructions

1. Print and complete the "Authorization for the Scattering at Sea of Cremated Remains" form.
2. The cremated remains must remain in the plastic/cardboard box in which you received them. Or if they are in another container, you may leave them there for shipping. Place this container inside another box.
3. Prepare a personal check, cashier's check or money order for the appropriate amount made out to: Oceanic West, Inc.
4. Enclose your personal check, money order or cashier's check in the outer shipping container.
5. Enclose the completed Authorization for the Scattering of Cremated Remains at Sea.
6. Enclose the *Application and Permit for Disposition of Human Remains* (VS 9) burial permit (this is a California form and is not necessary for cremations that were performed in other states or for scatterings outside of California) authorizing disposition of the remains.
7. Ship the cremated remains via U.S. Postal Service, to Oceanic West, Inc. Please call or email for the correct address depending on your scattering location.

Oceanic West is not responsible for any loss or damage of cremated remains shipped via the United States Postal Service.

If no special instructions are provided, the scattering at sea will be performed by Oceanic West at a time and location at its discretion.
