- 1. Meeting called to order and roll call. Mayor Rowell called the Regular Meeting of the Board of Trustees to order. Clerk Ray called roll and declared a quorum. Agenda was posted at the Calumet Town Hall on Monday January 7, 2019.
- 2. Public Comments Citizen's comments will be heard at all Regularly Scheduled board meetings only during the designated Public Comment portion of the agenda. Comments are limited to three minutes with no action taken. Mike Crowly addressed the board with concerns on the addition of a new employee for the Calumet Public Works Department, he stated that he did not feel that the department would need a third person working full time in this department. Maybe this employee if hired would be more of a manager of the town and help in all the departments as needed. No Action.
