Waves Swim School is available for private parties based on availability and by reservation only. Pool Party consists of 1 1/2 hours of swimming followed by 30 minutes of picnic area. Parties are subject to the conditions outlined below. The purpose of the guidelines is to establish standard procedures and must always be followed. Refusal to abide by the terms and conditions of this agreement may result in the loss the privileges.

Party Rental Terms & Conditions

1. Pool party hosts may arrive 30 minutes prior to party start time to set up party items. Party host shall ensure the grass, pool, deck area and pool house are orderly and free of trash prior to leaving; to include any items brought into the area by guests.
2. Pool host acknowledges and assumes all financial responsibility and liability to rental area, pool, equipment and restrooms.
3. Pool host assumes all personal injury liability for guests during the event.
4. Private Parties are a alcohol and tobacco-free environment. Violators will be asked to leave the facility.
5. Guests may not enter the pool until designated pool time, lifeguards are in place and given permission.
6. All Swimmers must wear appropriate swim attire to enter the pool.
7. Disposable diapers are not allowed in the pool. Reusable cloth swim diapers are required for all children under 3 years old or younger, and anyone not potty trained. **NO EXCEPTIONS!**
8. Party host shall be present at the pool throughout the reservation period and is responsible for the conduct of their guests.
9. A parent must supervise their child while in the pool. Children under 4 must have an adult in the water, within arm's reach always.
10. There will be no large flotation devices such as rafts, tubes or lounge chairs. **ONLY** Coast Guard Approved LIFEVESTS are permitted. No other flotation or floaties allowed. **THIS INCLUDES PUDDLE JUMPERS OR THE LIKE.**
11. All guests will be asked to exit the pool up to 30 minutes before pool reservation time is over to cut the cake and clean-up. Shortly after that time, the pool will be covered.
12. Glass containers are strictly prohibited.
13. We reserve the right to refuse the pool to anyone wo doesn't conduct themselves in a safe manner or not conform to the pool safety rules.
14. Party attendees must leave premises within fifteen (15) minutes after party ending time.

15. In the event of dangerous conditions all guests will evacuate the pool area immediately at the direction of the on-duty lifeguards.
16. Please inform your guests that they will enter through the iron gate between the main house and pool house.
17. Management has the right to stop or cancel a party at any time.
18. No oral agreement for the use of Waves Swim School shall be valid. All reservations must be confirmed with a written contract and approved by Waves Management team.

Our pool terms & conditions have been set up for your safety and for the wellbeing of you and your guests. Please make sure your guests are made aware of these safety rules, as you are ultimately responsible for the actions and the conduct of those you have chosen to attend your party on our premises. Lifeguard (s) is/are always in charge. Adults in attendance are expected to assist and cooperate with the lifeguard(s). Repeated warning from the lifeguard will be grounds for ejection from the facility.

***Any guest with special health requirements should be brought to the lifeguard(s) attention upon arrival.**

RATES:

- **Two (2) Hours Facility Fee: \$200- includes up to 25 people and two (2) lifeguards (swimming and non-swimmers)**
- **Additional hour(s) are \$150**
-
- **Additional Lifeguard(s) rate of \$25 hour per 25 guests. With a maximum of 70 people.**
- **A non-refundable deposit of \$100 is due at the time of reservation. Deposit is to hold the date and time. If cancelled, there will be no refund.**

***Confirmation of the number of guests is required at least 48 hours before the Rental start time to assure proper Lifeguard coverage.**
