The regular meeting of the Greenbush Township Board was held March 7, 2016 at 7:00PM. The meeting was called to order by Supervisor Jones and the Pledge of Allegiance followed. Havens was absent.

Hayes made a motion to approve the agenda, Jones supported. The motion carried.

The minutes from the last Board meeting were read. Jones made a motion to approve them as read, Smith supported, and the motion carried.

Hayes made a motion to pay orders 1397 thru 1417 plus the Consumers bill when it comes, for a total transfer of \$15,363.23, Jones supported and it carried.

Public comment came from Jerry Filwock concerning attorney fees, Ted Lewis concerning attorney correspondence, Brian LaBar concerning the Washington Township contract with CAFR, and Dan Palmer concerning the truck traffic on Hyde Road.

There were questions, comments and discussion concerning CAFR and what is happening as a result of Victor Township leaving.

Lynn Weber, Director of CAAS, spoke of its activities and growth as well as the concerns if we lose the first responders associated with CAFR.

Our county commissioner, Kam Washburn, reports Clinton County is calling the bond early for the health department building. This will save the County a significant amount in interest, and when paid off, the county will have no general fund debt obligation. The Clinton Transit budget has been approved and a renewal for their funding will be on the November ballot. A public hearing on Clinton County planning is to take place. The remonumentation program has been approved again. This sets the corner markers for surveying.

Our township assessor, Beth Botke reports the assessment notices have went out. The total change for Greenbush Township was 6.29% this year. The Consumers Price Index multiplier for 2016 taxable value is a 1.003 increase from 2015

Jones made a motion to amend the 2015-2016 budget Assessors Expense to \$828.76, Fire/Rescue billing to \$892.50, Legal Fees \$2,441.44 and Trustee Wages to \$4,391.96. Hayes supported and the motion carried.

Jones made a motion to approve the 2016-2017 Budget as amended, Smith supported and the motion carried.

Jones made a motion to approve the Clinton Area Ambulance Service budget as presented, Smith supported and the motion carried.

Jones made a motion to adjourn at 9:14 PM, Smith supported and the meeting adjourned.
