Mendi presented the Financials of the 2025 SC State Championships, highlighting some of the differences between the three State Championships, as well as some of the additional expenses for having to move the location of the Level 6, 7, Xcel Silver, Platinum, Diamond State Championship. Mendi presented the projected partial financials for the 2026 State Championships with the adjusted levels for each meet.
