# THE CANADIAN INFLUENCE & HISTORY WITHIN PESC

In 1999 for PESC's 1st Annual Best Practices Competition, OUAC was awarded 1st Place for its submission, "Ontario Universities Electronic Transcript System (OUETS): A Model of an Electronic Standardization Initiative."

In 2007 for PESC's 10th Year Anniversary, the PESC Fall 2007 Data Summit was held at the Ritz-Carlton Hotel in Montreal.

In 2011 at the PESC Fall 2011 Data Summit held October 26, 2011 in San Francisco, PESC launched the Canadian PESC User Group, with William McKee of OCAS as Co-Chair.

In 2012 for PESC's 14th Annual Best Practices, OCAS was awarded 1st Place for "OCAS XML Transcript Initiative."

In 2012, for PESC's 15th Year Anniversary, the PESC Fall 2012 Data Summit was held at the Four Seasons Hotel in Vancouver.

From 2013-2015 OCAS' William McKee was elected and served on the PESC Board of Directors,

In 2013 through establishment of CanPESC, PESC entered into a formal MOU with ARUCC, allowing ARUCC and PESC to attend each other's events without charge, thereby fostering a closer working relationship.

In 2013 and 2016 OUAC's Doug Holmes and OUAC's Leisa Wellsman, respectively, were recognized with PESC's Distinguished Service Award.

In 2017 for PESC's 20th Year Anniversary, the PESC Fall 2017 Data Summit "Advancing Student Mobility in a Digital World" was held at the Radisson Waterfront Hotel in Toronto.

In 2018 CanPESC Co-Chairs Cathy van Soest and Doug Holmes were appointed to the ARUCC/GDN & Student Mobility Project Steering Committee; and PESC President & CEO Michael Sessa was appointed to the ARUCC/GDN & Student Mobility Project Technical Advisory Committee.

In 2018 at the PESC Fall 2018 Data Summit in San Francisco, Charmaine Hack, ARUCC Past-President and Chair of the ARUCC/GDN & Student Mobility Project, served as Keynote Speaker.

In 2018/2019 for PESC's 20th Annual Best Practices Competition, the Council on Admission & Transfer for Nova Scotia (CATNS) was awarded 1st Place for its submission, "MyTranscripts | Nova Scotia's Electronic Transcript & Data Exchange System."

In 2019 EducationPlannerBC's's Cathy van Soest was recognized with PESC's Distinguished Service Award.

In 2019 in support of a new collaborative arrangement, the Fall 2019 Data Summit was held in Montreal at Le Centre Sheraton Montreal Hotel in Partnership with the Groningen Declaration Network. PESC's Summit hosted the Board of Directors of the Groningen Declaration Network, the Board of Directors of PESC, a day-long meeting of CanPESC at McGill University, the AACRAO SPEEDE Committee, a silent auction benefiting Indspire, and a day-long Retreat of the ARUCC/GDN & Student Mobility Project, in addition to General (Plenary) and Breakout Sessions.

In 2020 Joanne Duklas of Duklas Cornerstone Consulting was recognized with PESC's Distinguished Service Award.

In 2021 for PESC's 22nd Annual Best Practices Competition, ARUCC was awarded 1st Place for its submission, "MyCreds™ | MesCertif™" for mobile learner role.

In 2021 Romesh Vadivel of McGill University and Charmaine Hack of Centennial College were recognized with PESC's Distinguished Service Awards.

In 2021 CanPESC's Common Digital Layout Working Group produced the *Common Digital Layout*, with the central goal of identifying opportunities for institutions and transcript hubs to implement a transcript-to-PDF solution using PESC standard XML data designed to normalize the visual experience for end users.

In 2022 OUAC's Doug Holmes was recognized with PESC's 25th Anniversary Outstanding Service Award.

# CANPESC – THE VOICE FOR DIGITAL STUDENT DATA

Collaboration throughout Canada is nurtured, robust and inspirational. Like in the US, transition from paper processes toward more digital and mobile methods has been incremental, with promising yet intermittent successes. The challenges faced in implementing and maintaining systems and technology – from budgeting to development to governance, among many others – are corresponding similar and sometimes overwhelming.

**PESC’s founding in 1997 was made by a small, passionate community of individuals in collaboration with Canada and Canadian representation is woven into every fabric of PESC.**

PESC learned from its founding members like AACRAO, EFC, Ellucian, NASFAA and the US Department of Education, about the value of collaboration and adopted best practice models from organizations like ANSI and SPEEDE. At its heart, the PESC community looks to and desires to improve their technology and overall interoperability.

To accomplish their common goals and overcome the many challenges, these individuals understand the need to seek education, guidance and best practices on emerging technology and standards. They value networking and connecting with others with similar interests in an open, friendly environment to discuss new ideas and innovations. These shared values still remain true and when convened as a community, create a powerful force.

**As systems and technology have grown and expanded, so did the need to institutionalize Canadian representation within PESC. And so, as they say, the Canadian Postsecondary Electronic Standards Council (CanPESC) was formed in 2011 as a permanent group within PESC.**

CanPESC fostered the relationship – now a solid, formal partnership – between PESC and ARUCC. In meeting monthly since its founding, CanPESC collaborates across all provinces and territories to discuss common problems and common solutions. CanPESC has produced valuable outputs like the Common Digital Layout, and supports critical initiatives like the ARUCC/PCCAT Transcript & Transfer Guide, and MyCreds™ | MesCertif™.

As a semi-autonomous group within PESC, yet under jurisdiction of the Board of Directors and the PESC mission, CanPESC has the freedom and ability to set its own agenda. CanPESC has met during every Data Summit and has met separately (in day-long convenings) at OUAC in Guelph (2018) and McGill University in Montreal (2019).

**As we emerge into the next chapter of our digital journey, we reconvene to further the legacy of innovation and collaboration, and proudly announce the CanPESC Annual Meeting 2022 for October 25, 2022!**

# PESC AND THE TRANSFORMATION OF ACADEMIC CREDENTIALING & EXPERIENTIAL LEARNING

**2015** | In June 2015, at its annual planning retreat, the PESC Board of Directors, due to the emergence of credentialing on the international landscape, authorized the formation of **PESC's Academic Credentialing and Experiential Learning Task Force**. This Task Force formed and convened for its inaugural meeting at PESC's Fall 2015 Data Summit in Washington, D.C.

With Tom Black, Associate Vice Provost for Student Affairs & University Registrar at Stanford University (at the time), as Task Force Chair, and Co-Chairs Joellen Shendy, Associate Vice Provost and Registrar at the University of Maryland University College (at the time) and Alex Jackl, CEO and Founder of Bardic Systems, the Task Force committed to monitoring, tracking & discussing current initiatives related to skills & competencies; serving as a clearinghouse, point of contact, and community forum; providing speakers and presenters at several industry-leading conferences and events; and ensuring standards development work within PESC would be launched when/if the community reaches the point in which standards are needed.

**2016** | In June 2016 at its next annual planning retreat, the PESC Board of Directors discussed the need to showcase how all the different groups and initiatives focusing on credentials relate to one another; and authorized the dedication of PESC's Spring 2017 Data Summit in Washington, D.C. to one theme and purpose – *Empowering the Mobility of Digital Academic Credentials*. At this Summit, the Academic Credentialing & Experiential Learning Task Force collaborated with Credential Engine to host and launch the Credential Data Mapping Initiative – to map or crosswalk standards across standards bodies – and partnered with A4L, ADL, CEDS, HR Open Standards, and 1EdTech.

**2017** | Through analysis and its grant with AACRAO, funded by the Lumina Foundation, Chair Tom Black identified the need for standards in the exchange of certificates, degrees and diplomas. Work began immediately on the XML *Common Credential for Certificates, Degrees and Diplomas* which became a PESC Approved Standard on March 31, 2017 and was implemented by Stanford University. (Note the standard has since been replaced.) **HR MOU**

**2018** | At the Spring 2018 Data Summit *Best Practices in Education Data Systems* in Washington, D.C., PESC hosted the U.S. Chamber of Commerce Foundation and Lumina Foundation on a panel to promote *Web 3.0 Technologies in the Talent Market* and the launch of the **T3 Innovation Network**. PESC also hosted a separate convening at the Summit of the T3 Innovation Network. PESC subsequently joined and became a Member of T3. Also in 2018, PESC became a signatory to the *Bologna Open Recognition Declaration*.

**2019** | At the Spring 2019 Data Summit in Washington, D.C. *State of Technology & Standards in Higher Education*, PESC launched the **Competencies & Credentials User Group**. This User Group, the third major effort under the Academic Credentialing & Experiential Learning Task Force, was established to support efforts of the T3 Innovation Network and PESC's generous grant from the U.S. Chamber of Commerce Foundation.

**2020 & 2021** | With the advent of the COVID-19 pandemic, efforts continued with virtual convenings, though progress occurred at an understandably slower pace.

**2022** | With an eventual return to normal, PESC is launching the **Microcredentials in Data Systems & Lifelong Learning Task Force** at the October 2022 Data Summit *Unlocking the Power of Student Data* in Vancouver. This User Group, the fourth major effort under the Academic Credentialing & Experiential Learning Task Force, will study and investigate skills, microcredentials, competencies and related topics – and provide education and trends for future development.

The T3 Innovation Network is exploring the emerging technologies and standards in the talent marketplace to create more equitable and effective learning and career pathways. Our talent marketplace is fragmented, preventing an individual’s record of learning from being transferable data. And any data that is collected, is siloed.

People often can’t communicate what they know and are able to do in ways that are meaningful to employers. Yet employers, trying to find the right talent to fit their needs, rely on a person’s ability to communicate the value of their skills and experience. The T3 Innovation Network is solving that.

This network has grown to more than 500 organizations working together to change the way we provide, access, and use educational and workforce data by using advanced technologies like AI, blockchain, and others to create an open and decentralized public-private data ecosystem. As a result of this work, rather than hunting down data, job seekers will be able to display the breadth of their experience in a single, comprehensive learning record.

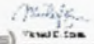

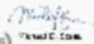

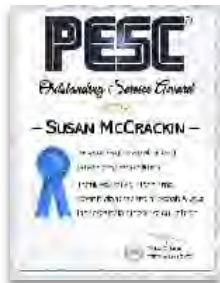
### **DOUG HOLMES, MANAGER, eTRANSCRIPTS, OUAC**

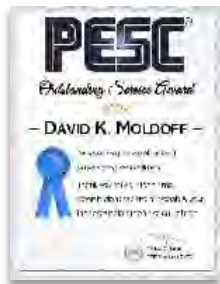
### **JENNIFER KIM, DIRECTOR OF MEMBERSHIP SERVICES, PESC**

The Board of Directors of the Postsecondary Electronic Standards Council (PESC) consists of twelve (12) elected representatives from Member organizations (serving two-year, staggered terms) and the President & CEO who together have overall authority to govern PESC and administer all corresponding policies and procedures.

The Board of Directors abides by *Roberts Rules of Order* and the *PESC Board Manual of Roles & Responsibilities*; and meets monthly (virtually), in-person at annual Data Summits, and for its Annual Retreat each June.

# PESC BOARD OF DIRECTORS

Annual elections for the PESC Board of Directors are held each April with election results announced during the annual April Data Summit. At Annual Retreats, the Board of Directors approves the annual PESC budget for the following fiscal year, conducts evaluation and review exercises and elects Officers (Chair, Vice Chair, Treasurer and Secretary).
