The FGHA Board Meeting was called to order at 7:02PM. Board Members in attendance were: Steve Strauss – President, Roland Bardonay – Parks Director, Steve Stanovcak -- Pool Director, Christine Saenz – Social Director, and Rich Neve – Civics Director.



If you have been following financial news, you have heard about the fed raising their rate. This indirectly affects the mortgage interest rate. The rate has climbed significantly within the past two weeks. In one day it jumped over one point. While this is impacting buyers, it is also important to put into perspective that our mortgage rates have been kept artificially low for nearly a decade. Anything in the 5% to 8% range was historically considered normal. Our market has been affected in that transactions are falling out of escrow and receiving just one offer or none at all. The silver lining to this is

that our home values have benefited from YEARS of value run-ups. So, while the peak may have been reached in April of this year, the home prices will stabilize or slightly decrease.
