- All Contestants must be a resident of Calhoun County.
- Each Queen/Miss Cowgirl/Jr. Miss Cowgirl/Little Miss Cowgirl/Little Mr. Cowboy/Tiny Miss Cowgirl & Tiny
 Mr. Cowboy contestants must obtain at least three (3) \$40.00 sponsors. Sponsors can be businesses,
 family members or friends. Out of County sponsors are accepted as well. (Please copy the sponsor form
 as needed.)
- Any sponsors writing a check please make it payable to The Calhoun County Fair Association. Personal
 check's MUST include the sponsor's Driver's Licenses number and a phone number. Any returned checks
 will automatically be turned over to the Calhoun County District Attorney's Office immediately.
- Contestants MUST turn in completed application and sponsor forms with the sponsor money attached.
- Any Contestant wanting to enter the Most Photogenic Category must submit a photo with application (which will be returned) or email photo to deckardkingslee@gmail.com or michalablinka@gmail.com with contestants name and the pageant as title. (Example = Sally Smith Little Miss Cowgirl). If you email please wait for an email back that confirms receipt of your photo. Contestant photo should be from the waist up with a clear shot of your child's face (it does not have to be in western wear).
- Final due date for the Queen/Miss Cowgirl/Jr. Miss Cowgirl/Little Miss Cowgirl/Little Mr. Cowboy/Tiny Miss Cowgirl & Tiny Mr. Cowboy application and sponsor money will be Friday, October 4, 2024 @ 5:00pm. No late entries or sponsor money will be accepted after the final due date.

We are providing a trailer for all the Miss Cowgirl/Jr. Miss Cowgirl/Little Miss Cowgirl/Little Mr. Cowboy/Tiny Miss Cowgirl & Tiny Mr. Cowboy contestants. (Parade attire will be western wear)
- Queen contestants MUST provide and decorate their own individual float/vehicle for the fair parade. The CONTESTANTS NAME and 2024 CALHOUN COUNTY FAIR QUEEN CONTESTANT should appear on each side of the float/vehicle. (Parade attire will be western wear)

- Queen contestants MUST attend an interview session which will be held on Sunday, October 13, 2024
 ② 2:00pm at the Calhoun County Extension Office located at the Fairgrounds, 186 Henry Barber Way, Port Lavaca, Texas 77979. Interview attire will be business/church wear (dress as if you were going for a job interview.)
- Pageant Rehearsal is MANDATORY for all contestants and will be held on Monday, October 14, 2024
 6:00pm. We will begin with Tiny Mr. Cowboy and Tiny Miss Cowgirl; Little Mr. Cowboy and Little Miss Cowgirl; Jr. Miss Cowgirl; Miss Cowgirl and then the Queen contestants.
- Jr. Miss Cowgirl/Little Miss Cowgirl/Little Mr. Cowboy/Tiny Miss Cowgirl & Tiny Mr. Cowboy contestants will need to be at the Fairground Pavilion the day of the pageant, Tuesday, October 15, 2024 @ 5:30pm. The Miss Cowgirl & Queen contestants can arrive @ 7:30 pm.
- Contestants will wear western attire (jeans, western style shirt and boots, western skirt/dress are acceptable). Cowboy hats and accessories are optional. NO PROPS will be allowed.
- Pageant winners must remain enrolled in Calhoun County ISD and each contestant must comply with No Pass, No Play Rules throughout his/her reign. Failure to do so will result in relinquishment of his/her title and prizes.
- The Calhoun County Fair Pageant WILL NOT tolerate bullying of any kind. Bullying made in a verbal or written expression, expression through electronic means (Cyberbullying) or physical conduct. Failure to do so will result in relinquishment of his/her title and prizes.
- Any behavior of the contestant's parent(s) deemed inappropriate by the Calhoun County Fair Pageant Committee will result in relinquishment of his/her title and prizes.
- The winners are required to help clean up the fairgrounds on Sunday, October 20th, 2024. We will notify you of the time to be there via text. **THIS IS MANDATORY**.
- If the winner cannot fulfill his/her obligations throughout their reign, All prizes must be relinquished and the title will be awarded to the 1st runner up at any time throughout the year.
- I will not participate in any other pageants without the permission of the Pageant Director. I understand that if I choose to compete in any other pageant, and win a title in that pageant, that my first obligation is to the Calhoun County Fair Pageant Court. I understand that if I choose to represent the other pageant program I will forfeit my current Calhoun County Fair Pageant title and awards.
