Summary: On Thursday, June 2, 2021 at approximately 4:17am, officers from the Wildwood Crest Police Department responded to the 7900 block of Atlantic Avenue for a report of a dispute in a motor vehicle. Upon arrival, officers located a female victim and determined that she had been physically assaulted by Quenton Skrine, which resulted in bodily injury. Skrine was also located and detained during the investigation.

While placing Skrine under arrest, it was discovered that he was in possession of a loaded magazine containing hollow point bullets. Officers canvassed the area and located a loaded handgun near to where the dispute had occurred. Further investigation revealed that the handgun was reported stolen out of York, PA.

Skrine was transported to Wildwood Crest Police Headquarters where he was charged with Aggravated Assault, Unlawful Possession of a Weapon, Possession of a Weapon for an Unlawful Purpose, Receiving Stolen Property, and Prohibited Weapons and Devices (hollow point ammunition). He was placed on a warrant and lodged at the Cape May County Correctional Facility to await a bail hearing.

It should be noted that all person(s) arrested are innocent unless proven guilty.
