We the People Summer Institute Offers Training for Educators

The Louisiana Center for Law and Civic Education (LCLCE) presented the Louisiana We the People Summer Institute in July at Louisiana State University Paul M. Hebert Law Center in Baton Rouge. An intensive seven-day teachers' workshop, the Summer Institute provided professional development at the elementary, middle and high school levels. This program was provided at no cost to Louisiana teachers who received lodging, meals and free We the People textbooks for their classrooms.

LSU Law Center Chancellor Jack M. Weiss addressed the group. Also, six constitutional scholars from across the nation participated as lecturers and provided personal insight in areas that correlated with the *We the People* curriculum. Each afternoon, participants were given interactive training sessions on how to implement the program in the classroom. The culminating activity was a simulated congressional hearing performed by each of the participants.

At the event's closing ceremonies, LCLCE President Brian J. Engeron expressed his appreciation to the teachers for their dedication in developing their skills as educators. Engeron presented each teacher with a certificate of continuing learning units.

The constitutional scholars were Justice (Ret.) Susan Leeson, Oregon Supreme Court; John Kaminski, professor of history, Center for the Study of the American Constitution; Jasmine Farrier, Ph.D., associate professor, University of Louisville; Robert L. Gutwein, adjunct professor of law, Indiana University, CEO, Health and Hospital Corporation of Marion County; and Thomas S. Vontz, Ph.D., associate professor and director, Center for Social Studies Education, Kansas State University.
