Brochures: Brochures are FREE! There are NO upfront costs to ship our Brochures to your organization. We request no cancellations!

Profit: Candle Brochures - Organizations can earn up to 50% profit with our brochures. Organization will pay 50% of the retail selling price plus tax, if shipped to TX, for orders with 250 or more items, 60% for orders less than 250 items. Organizations are invoiced for only the actual amount due. Profit is retained by the organization.

Product Availability/Pricing Guarantee: Brochures are valid through 12/31/17. For Christmas Delivery, we recommend payment be received by 12/08/16. Invoice must be received by the retirement date. Many items will no longer be available following retirement date.

Samples, Late Orders: No product minimum required. Regular pricing applies for samples and late orders, \$15.00 shipping fee applies.

Sales Tax: LaTeeDa will collect tax only for shipments to TX. If your organization is not start tax exempt, you will be responsible for collection and paying the sales tax to you state unless you are in the state of TX. LaTeeDa collects and pays the sales tax on your behalf to the state of TX.

Shipping: Shipping is free with retail sales of \$150 or greater. If an order is less than \$150 in retail sales a \$15 shipping fee is added. Shipping rates are subject to change. All orders are shipped FedEx Ground. There are no additional fees for orders packed-by-seller.

Payments: Customer checks are made payable to your organization. A single payment by Money Order, School or Organization Check will be accepted for your purchase. Personal checks, temporary checks, checks with hand-written group/business names can't be accepted. Credit cards are accepted with receipt of a signed credit card authorization. Purchase Orders are accepted for public schools. Payments by check/money orders must be paid in full prior to the order being placed. Returned checks will be charged \$50.00.

Pack-By-Seller: Provided Free. If opted for, an online link will be provided to the organization for entering each participant's order.

Delivery: Products are generally delivered within 7 business days from the date your payment/purchase order is received.

Check-In Forms: Replacements for missing or broken items will be shipped only when a fully completed Check-In Form has been submitted within 72 hours. Phone calls or emails alone WILL NOT be accepted. No exceptions. Organization will be responsible for the accuracy of the total number of items sold and ordered.

Sales Agreement: MUST be returned to Deb Murray prior to distributing your brochures. I have read, understand and agree with the terms and conditions listed above and have received approval from my organization (school principal, board members etc.) to sign on behalf of my organization.
