1. HAYS COUNTY YOUTH SHOW GENERAL RULES

1.1 INVITATIONAL SHOW: This is an invitational show. The HCLE Board of Directors reserves the right to extend or withhold an invitation to any contestant.

1.2 RULES INTERPRETATIONS AND VIOLATIONS:

Exhibitors are requested to report any rule violation(s) to the appropriate division superintendent immediately so that appropriate action may be taken. The Hays County Livestock Expo, Inc. (HCLE) reserves the final and absolute right to interpret these rules and settle and determine all matters, questions and differences in regard thereto, or arising out of, or in connection with, or incident to, the exposition and to amend or add to these rules. Exhibitors who violate any of the rules will forfeit all privileges and premiums and will be subject to such a penalty as the HCLE Board of Directors may order.

1.3 SPECIAL RULES: Special Rules are published in any department where necessary. If there is a conflict between the Special Rules and the General Rules, the Special Rules will govern.

1.4 LIABILITY: All exhibits will be under the direction of the hosting organization, but in no case will the Hays County Livestock Exposition, Inc. (HCLE), their respective agents, directors, officers, managers, employees, and volunteers will be responsible for any loss, injury or damage which may occur. The exhibitor will be solely responsible for their projects and any consequential or other loss, injury, or damage done to, or occasioned by, or arising from, any animal or property exhibited by him/her. Exhibitors shall indemnify and hold HCLE harmless against any and all claims, demands, damages, costs, and expenses, including reasonable attorney's fees for defense thereof arising out of conduct or management of the show, including, but not limited to, their negligence. In no case will HCLE, its directors, officers, managers, employees, or volunteers be held responsible for any loss, damage, or injury of any character, person, animal, or article while on HCLE grounds at the event or at any other time or place caused by the exhibitor or any animals exhibited with such exhibition, or any of the animals so exhibited. All owners or persons in charge of property or animals shall care for, guard, protect, and preserve the same, as HCLE does not undertake to do so, and it shall not be held responsible for any loss, shrink, animals, owners, or exhibitors thereof.

1.5 DISPUTES AND PROTESTS: All protests or other matters must be submitted in writing within 24 hours and accompanied

with a deposit of \$100, which will be forfeited if the protest is not sustained. Such a protest must plainly state the cause of the complaint or appeal and must be delivered to the appropriate division superintendent immediately after the occasion for the protest. All protests will be reviewed by an Executive Board of the Hays County Livestock Exposition, Inc. Judges' and classifiers' decisions will be final and may not be protested. Weight backs may not be protested.

1.6 ACADEMIC ELIGIBILITY: According to UIL Guidelines students must be academically eligible to participate in such an event. This would mean that they will need to be passing as of the grading period prior to the event. For competitive 4-H or FFA-sponsored events, youth participants must be academically eligible per current guidelines as set forth by the Texas Education Agency. Youth exhibitors and contestants who have been suspended under **Texas Education Code 33.081 "No Pass, No Play"** are ineligible to participate in any Hays County Livestock Exposition Inc. activity, event or competition. **Any animal owned by an ineligible exhibitor is ineligible for competition.** As of January 12th, all Hays County 4-H and FFA exhibitors are considered to be eligible by the Hays County Livestock Exposition Inc. to participate in the Youth Livestock Show. Any AST/CEA, FFA, FCCLA advisor who has a member in his/her 4-H or FFA program who becomes ineligible to participate in the Youth Livestock Show according to the Texas Education Code must provide written and signed notification to the Hays County Livestock Exposition, Inc. Board and the appropriate division superintendent prior to check-in.

1.7 GENERAL ELIGIBILITY: Participants must be a member of a Hays County FFA Chapter, FCCLA or 4-H Club. Participants must reside within the geographic boundaries of a Hays County School District or attend a public or private school located within Hays County. Participants must be in good standing in an FFA Chapter and/or 4-H Club in Hays County at the time of the Show. ****Good Standing** means that a youth participant must have met the attendance requirement of attending three (3) meetings and/or events of the organizations between the months of August through January. FFA Advisors and CEA's will certify eligibility of all of the chapter/club exhibitors to the Hays County Livestock Exposition, Inc Board. Exhibitors who do not follow this eligibility will not be allowed to participate in the Hays County Youth Livestock Show. The Hays County Livestock Exposition, Inc. Board has the final determination of General Eligibility.

1.8 OTHER COUNTY SHOWS: The participant and/or project may not enter or participate in another county youth show in Texas other than Hays County in the same school year.

1.9 OWNERSHIP/VALIDATION DATES AND FEES: All exhibitors, regardless of species or project, shall abide by the standards established by the current Texas 4-H/FFA Livestock Program Ethics Policy. The ownership and validation dates specifically pertaining to our show are as shown below.

1.11 HORSE OWNERSHIP: An affidavit of ownership or 4-H lease is necessary to enter grade horses. For registered horses, completed registration papers prior to November 1 through the breed registry/association will prove ownership. Transfer papers will not be accepted as proof of ownership. For registered horses

that are leased, please complete the Texas 4-H Lease Horse Agreement. Papers must be submitted to the Texas A&M AgriLife Extension Office, Hays County.

1.12 VALIDATION TAGS: A state validation tag, tattoo, or registration papers are required at check-in. If a tag is lost or pulled out, contact the division superintendent AND County Extension Agent within 24 hours of the loss. If a band is lost on poultry, it is ineligible for any show (county or majors). You may contact the division superintendent or County Extension Agent if you have a questionable or loose band to reband, however rebanded poultry are ineligible for majors and can only be shown at the Hays County Livestock Show. Validation tag must be properly affixed to all animals before entering the show barn.

DECLARATION FOR BREEDING ANIMALS: Declaration of whether the animal shows in market or breeding will be done at check in as long as two entries have been paid for the animal to show in either market or breeding. ****For clarification, this means that a paid market entry AND a paid breeding entry are required in order to have a choice at check-in. It does NOT mean that a single animal can show in both classes.****

1.14 ENTRY DEADLINE: All entries must be submitted online and paid in full by 11:59pm on the third Wednesday of December. There will be NO REFUNDS ON ENTRY FEES. Late entries for ALL PROJECTS will be accepted up to check-in on:

- January 18, 2026, for Ag Mechanics
- January 19, 2026, for Home Skills
- January 19, 2026, for Rabbits, Goats and Sheep
- January 20, 2026, for Swine
- January 21, 2026, for Cattle and Poultry

with an additional late fee of \$300.00 per project/per species as long as the exhibitor has met the general eligibility.

1.15 ENTRY FEES AND ACCEPTABLE PAYMENT: Cash is not accepted. Entry fees must be paid by Credit Card, personal check, cashier's check or money order. No personal checks for late entries.

1.16 ENTRY SIGNATURES: All required e-signatures must be on the entry form when it is submitted or a completed online entry for it to be considered valid.

1.17 MARKET ENTRIES: Up to four (4) entries will be allowed in all market classes except market rabbits which will be limited to two (2) pens and one fryer. To be eligible to enter one fryer the exhibitor must enter at least one pen of rabbits.

1.18 BREEDING ENTRIES: There will be no limit to entries that are allowed in each breeding division

1.19 OWNERSHIP DECLARATION: Once ownership has been declared at check-in, it will not be changed.

1.20 ANIMAL BEHAVIOR: For safety reasons, any animal deemed uncontrollable by the division superintendent must be removed from the show grounds by the exhibitor.

1.21 CHECK-IN: All species will be weighed, checked-in and classified by the Superintendent and Classifier. Weight cards will be turned in and be considered final. Validation tags must be properly affixed to all animals before entering the show barn.

1.22 SIFTING: All animals and poultry brought to the show must be of sufficient quality to show. A sifting committee may inspect all entries. Three classifiers and/or sifters may be used in each division to the discretion of the HCLE Board of Directors.

1.23 CHAMPIONS: One exhibitor may not win both the Grand Champion and Reserve Champion in the Market division.

1.24 ANIMAL SHOWMANSHIP: Awards will be made in beef, goat, poultry, rabbit, sheep and swine divisions in a separate showmanship class at the conclusion of each show. Age divisions are shown below and are as of the day of the show.

No entry fee will be charged and any exhibitor with an entry in a division may participate in that division. The exhibitor must be entered in that division to participate in showmanship.

1.25 AG MECHANICS SHOWMANSHIP: A showmanship award will be presented to one (1) Clover kid, one (1) Junior, one (1) Intermediate, and one (1) Senior exhibitor. Age divisions are shown below and are as of the day of the show.

1.26 HORSE SHOWMANSHIP: A showmanship award will be presented to one (1) Clover kid, one (1) Junior and one (1) Senior exhibitor. Age divisions are shown below and are as of the day of the show.

1.27 GROOMING, FITTING & FEEDING: Only Hays County Agriculture Teachers, Hays County Agents, and immediate family (mother, father, legal guardian, brother, sister and grandparents) may assist exhibitors with grooming, fitting & feeding on the show grounds during the Hays County Youth Show.

- Only the exhibitors, the official judge and his certified assistant and the show attendants tabulating the judging results, will be allowed in the judging ring.
- The only exception to this rule is for Broiler and Turkey Show where an adult or exhibitor may assist in the ring.
- A special needs exhibitor may be assisted by an exhibitor in that specific division.
- Groups in breeding animals (cow/calf, nannie/kid, ewe/lamb) may be assisted by an exhibitor in that specific division.

In the event of a safety concern arising, the decision and course of action will be determined by the executive committee.

1.28 EXHIBITOR SUBSTITUTION: Entries in the Hays County Youth Livestock Show must be shown by their owner. Exhibitor substitutions must follow the guidelines stated below:

- **An Exhibitor substitution form must be requested, completed and submitted at least one (1) hour prior to the start of that species show. The completed substitution form must be submitted to the division superintendent.**
- Exhibitor substitutions may be allowed under the following conditions. In all cases, the Department Superintendent must approve the exhibitor substitution and will do so only if all conditions are met:
 - a) **UIL or Standardized Testing:** This substitution request must be made in writing by the AST/CEA, parent/guardian or leader at the Show. This request must be made on the Official Hays County Youth Livestock Show Exhibitor Substitution Form provided by the Department Superintendent. This request must be accompanied by a letter signed by a School Administrator, on school letterhead stating the specific reason a substitute is requested. The completed Official Hays County Youth Livestock Show Exhibitor Substitution Form and the notarized statement must be returned to the Department Superintendent one (1) hour prior to the start of the respective show.
 - b) **Sickness:** This substitution request must be made in writing by the AST/CEA, parent/guardian, or leader at the Show. This request must be made on the Official Hays County Youth Livestock Show Exhibitor Substitution Form provided by the Department Superintendent. This

request must be accompanied by a statement, signed by a Physician, on his/her letterhead. The completed Official Hays County Youth Livestock Show Exhibitor Substitution Form and the Physician's statement must be returned to the Department Superintendent one (1) hour prior to the start of the respective Show.

- c) **More Than One Entry in a Class or the Exhibitor Has Entries In More Than One Department Show At The Same Time:** This substitution request must be made in writing by the AST/CEA, parent/guardian, or leader at the Show as soon as the problem arises, but in any case, no later than the start of the respective show. This request must be made on the Official Hays County Youth Livestock Show Exhibitor Substitution Form provided by the Department Superintendent. The completed Official Hays County Youth Livestock Show Exhibitor Substitution Form must be returned to the Department Superintendent one (1) hour prior to the start of the respective show.
- In any of the three (3) situations listed above, or in the case of an emergency, the Department Superintendent may use his/her own discretion as to whether a substitute showman will be allowed. If a positive decision is rendered, the substitute must be from the same school, FFA Chapter, or 4-H Club as the original exhibitor with the following two (2) exceptions:
 - a) The original exhibitor is the only exhibitor from that school, Chapter/Club entered in that Department.
 - b) All other members from that school, FFA Chapter, or 4-H Club, are exhibiting at the same time.
 - In either case, any Exhibitor (meeting all requirements of the Hays County Youth Livestock Show exhibitor in the Department entered) meeting the approval of the Department Superintendent may exhibit the animal.
 - Any Exhibitor with an approved Exhibitor substitution for the reason of UIL or Standardized Testing or Sickness will be ineligible to participate in Showmanship in that respective show.

1.29 ANIMAL TRIMMING: Trimming will be allowed on the show grounds with battery operated clippers for touch up only.

1.30 ANIMAL ELIGIBILITY: Any one animal is not eligible to participate in both the Market and Breeding Shows.

1.31 RELEASE TIMES: Release times and removed by will be designated by division superintendents.

1.32 ETHICAL ANIMAL FITTING: Entry of unethically fitted animals is prohibited and grounds for immediate dismissal.

Unethical fitting will include, but is not limited to, the following:

- a) Treating or massaging any part of the animal's body, internally or externally with an irritant, counter-irritant, or other substance to temporarily improve confirmation.
- b) Minimizing the effects of cramping by feeding or injecting drugs or depressants or by using any artificial contrivance or therapeutic treatment other than normal exercise.
- c) Blocking nerves to prevent limping or tail switching.
- d) Striking the animal to cause swelling.
- e) Surgery to change the natural contour or appearance of an animal's body, hide, or hair except for the removal of warts, horns, and permitted clipping and dressing of hair and hoof trimming.
- f) Insertion of foreign material under the skin.
- g) Changing the color of hair at any spot or area of the animal's body.
- h) The use of alcoholic or carbonated beverages in the feed or administered as a drench
- i) The use of diuretics.
- j) The act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other esophageal method.
- k) The administration of any FDA or USDA unapproved drug.
- l) Unethically fitting will be deemed to consist of changing the normal conformation of any part of the animal's body or using controlled substances, drugs- including but not limited to over the counter and/or extra-label, or mechanical devices to alter the physical makeup and/or performance of the animal, **with the exception of magnetic pulse energy therapy.**

1.33 DRUG TESTING: Drug testing may be performed on all Breed/Division Champions and Reserve Champions in Addition to one (1) animal, chosen randomly, from each Market show. Testing will be administered according to Standard drug testing protocols. All testing, sample Collection, and analysis will be paid for by the HCLE Board of Directors. Animals will be tested for steroids, Diuretics, and anti-inflammatories. Antibiotics will NOT be tested for.

1.34 PENALTY FOR POSITIVE DRUG TEST RESULT:

Exhibitors will be required to return all auction proceeds, buckles, and ribbons to the HCLE Board of Directors, for the animal that

tested positive. The results obtained by the analysis will be final. The exhibitor waives any right of recourse towards the HCLE Board of Directors, their appointed veterinarians, or the analyzing laboratory for actions taken against them as a result of this rule.

1.35 DRUG CERTIFICATION AGREEMENT: Included with each online entry, exhibitors, with their parent/guardian, will certify that their entry has not been administered any substance (by them or others) that has not been approved by the Food and Drug Administration (FDA) and/or the US Department of Agriculture (USDA) for food animals. Also, the exhibitor and parent/guardian will certify that their entry is free and clear of ALL drug and chemical residue withdrawal and have exceeded elimination time periods.

1.36 DOGS: Dogs are not allowed on the show grounds at any time. Support dogs are exempt from this rule.

1.37 SAFETY AND SECURITY: Any behavior deemed unsafe or unacceptable by the HCLE Board will result in immediate removal from the show grounds by security.

1.38 FRATERNIZATION: Parents and exhibitors may not talk to the judge or ring steward during the show. Failure to comply may result in the participant being disqualified from the show.

1.39 EXCESSIVE COACHING: A contestant may be disqualified from a class, at the division superintendent's discretion, for receiving excessive verbal instructions from outside the ring.

1.40 DRESS CODE: All exhibitors are required to wear appropriate show attire when competing. Shorts, tank tops, low cut shirts, sheer blouses, flip flops, T-shirts, ball caps, or bare midriffs are not acceptable show attire and therefore may not be worn during a show event.

1.41 TRAILER PARKING: All stock trailers must be parked in the designated trailer parking area. Those trailers left unattended and NOT within the designated parking area, after check-in and during the show, may be removed at the discretion of the HCLE Board.

1.42 VENDORS: Those who wish to charge for services on the show grounds must remit a vendor fee to the Hays County Youth Livestock Show board.

2. AMBASSADOR AND QUEEN'S COURT CONTEST

A. AMBASSADOR AND QUEEN'S COURT PROGRAM OVERVIEW

2.1 The Queen's Court will be composed of a Queen, a Princess, and Duchesses.

2.2 The Ambassador's Court will be composed of Senior Ambassador and Ambassadors.

2.3 The Queen's Court will have no more than nine girls.

2.4 The Ambassador's Court will have no more than nine boys.

2.5 The Ambassador's and Queen's Court Program will be organized and directed by the HCLE Scholarship, Ambassador, and Queen's Court Committee; hereafter referenced as *The Committee*.

2.6 In order to participate in the Ambassador and Queen's Court Contest, candidates must meet eligibility requirements, attend the mandatory meeting, submit an application, and participate in a personal interview.

2.7 A panel of judges will score each candidate based on his/her application and personal interview to determine the awarding of titles.

2.8 Title holders must fulfill duties and responsibilities as set forth by the committee.

2.9 Representatives of the Ambassador and Queen's Court will hold their titles for one year.

2.10 All questions or conflicts that arise must be addressed, by a phone call to the committee chair or superintendent. Contacts are as follows:

B. ELIGIBILITY

2.11 Prior to submitting his/her application, candidates must have shown in the Hays County Youth Livestock Show at least once during his/her 4-H or FFA career. In the event that a member of a Hays County 4-H Club of FFA Chapter moved to the county and has been unable to show in the Hays County Youth Livestock

Show, eligibility will be considered if the individual has previously participated in another 4-H or FFA's livestock show. If the previous circumstance applies, please contact the committee prior to the application due date.

2.12 Candidates must be enrolled in high school or be eligible to be enrolled in a high school in Hays County.

2.13 A selected candidate may only hold the title of Queen or Senior Ambassador for the duration of one year. Once a Queen or Senior Ambassador of the Hays County Youth Livestock Show has completed his/her reign, he/she will retain a place on the court and will be honored with the title of Senior Ambassador Emeritus or Queen Emeritus for the duration of their remaining high school years.

2.14 If a previous title holder has been released from his/her title, he/she may not apply for the court the following year. After one year, the individual's eligibility will be reconsidered at the discretion of the committee.

2.15 Queen's Court candidates may be any high school girl involved in 4-H or FFA in Hays County, as long as all other applicable eligibility requirements listed in this section are met.

2.16 Ambassador's Court candidates may be any high school boy involved in 4-H or FFA in Hays County, as long as all other applicable eligibility requirements listed in this section are met.

2.17 There will be no limit to the number of candidates from an individual club.

2.18 Potential candidates must attend a mandatory meeting with at least one parent or legal guardian. Date TBD Applicants who fail to attend will be disqualified from the contest. Please see Section 2. C for further details.

2.19 Candidates shall not display facial piercings, facial hair, tattoos, or unnaturally colored hair.

C. APPLICATION, RESUME, AND PHOTOGRAPH

2.20 The four hard copies and an electronic copy of the completed application must be submitted.

2.21 The completed, hard copy application must contain four individual 9x12 sealed envelopes of each of the following: application form, resume, reference letter, and photograph. All

aforementioned documents must be placed into a large 10x13 sealed envelope. Additionally, one copy of the entry form must be completed and attached to the front of the large 10x13 envelope, with all four sealed complete packets inside this 10x13 envelope. **DO NOT place the entry form inside the application envelope.**

2.22 The completed electronic copy of the application must contain a copy of each of the following: entry form, application form, resume, reference letter, and photograph. **All documents must be submitted in PDF format.** Please email all PDF documents in a single, zipped folder named in the following manner: *CandidateName_2025_2026*

2.23 The candidate's hard-copy application must be submitted to the Hays County Extension Office by 4:30pm on Wednesday October 1, 2025. The electronic copy of the completed application must be submitted via email Hayscountylivestockshow@gmail.com by 5:00pm on Wednesday, October 1, 2025.

2.24 Download application and entry forms from the HCLE website **www.hayscountylivestockshow.org**.

2.25 The resume must contain a description of activities and achievements in 4-H, FFA, civic, community, church, and school organizations. Please include honors won and any leadership positions held.

2.26 A reference letter must be included in each candidate's application. Four copies of the reference letter must be enclosed within the submitted, hard-copy application. Additionally, a copy of the reference letter must be included in the electronic submission.

2.27 Four (4) 4x6 copies of a headshot photograph of the candidate must accompany all entries. A scanned or electronic copy of the same photograph must be included in the electronic submission. Please ensure that the electronic copy is in PDF format. If necessary, the candidate may insert the photograph on a Microsoft Word document and save the document as a PDF.

D. JUDGES' PANELS

2.28 Prior to the interviews, the committee will select six judges from outside of Hays County to serve on the interview panels.

2.29 The judges will be formed into two panels of three judges, One Panel will interview the Queen's Court candidates, while the other will interview the Ambassador's candidates.

E. PERSONAL INTERVIEW, CANDIDATES' SCORE SHEETS, AND JUDGES' COMMENTS

2.30 The interview date will be Sunday, October 12, 2025, at the Hays County PCT 2 Offices 5458 FM 2770 Kyle, Texas 78640

2.31 Pending extenuating circumstances, such as complications surrounding the COVID-19 pandemic, the personal interview may be conducted using alternative methods.

2.32 The duration of each personal interview with the judges' panel will not exceed ten minutes.

2.33 Each judge on the panel will score each candidate's application and interview using a standard score sheet provided by the committee. The judges will also be able to add comments on the score sheets.

2.34 After the court has been announced, each candidate will receive a copy of their own score sheets and comments as marked by the judges.

2.35 It is intended that each candidate use his/her own score sheets and comments as a tool to learn in what areas he/she excelled and how he/she can make improvements in future applications and interviews. Score sheets ARE NOT provided so that the candidates or their parents/legal guardians may compare scores. These scores are intended for private and personal use. Please DO NOT abuse this privilege.

F. RESPONSIBILITIES

2.36 The Queen and Court will reign for one year.

2.37 If the Queen is unable to fulfill her responsibilities, the Princess will reign in her absence. If the Princess is unable, then the next highest scoring Duchess will reign in her absence.

2.38 The Senior Ambassador and Ambassadors will reign for one year.

2.39 If the Senior Ambassador is unable to fulfill his responsibilities, then the next highest scoring Ambassador will reign in his absence.

2.40 The Ambassador's and Queen's Court are required to be present at all livestock show events, including the auction, to fulfill the following responsibilities:

- a. Pass out awards at all events and be in show pictures.
- b. Pass out refreshments and assist the buyers at the auction.
- c. Be in auction pictures
- d. Be available for miscellaneous duties as the by both the HCLE Board and the committee throughout the livestock show.
- e. Attend and help at the HCLE Dance.
- f. Attend other livestock show related events throughout the year.

2.41 The Ambassador and Queen's Court representatives are required to attend certain community events throughout the year, as determined by the committee and HCLE Board.

2.42 The Queen's Court representatives must wear their tiaras and sashes at all events unless participating as an exhibitor at the livestock show.

2.43 Ambassadors must wear their Ambassadors' vests and badges at all events, unless participating as an exhibitor at the livestock show.

2.44 It is the responsibility of each Ambassador and Queen's Court representative to sell, at minimum, the required number of raffle tickets he/she is assigned.

G. SCHOLARSHIP, AMBASSADOR AND QUEEN'S COURT COMMITTEE

2.45 A committee will be formed each year and will consist of at least one HCLE Board member and at least 3 volunteers.

2.46 The committee has the discretion to remove any Ambassador and Queen's Court representative who does not fulfill his/her commitments and/or conducts himself/herself in a manner deemed inappropriate.

2.47 The committee has the discretion to make changes to the program as needed.

2.48 In honor of Dr. Glen & Mary Lou Rydl, a \$1250 Scholarship (\$750 from HCLE & \$500 from Dr. Rydl) will be given to the Queen upon proof of enrollment of a college, university, or technical trade school.

2.49 The Hays County Livestock Exposition (HCLE) will give a \$750.00 scholarship to the Senior Ambassador upon proof of enrollment in a college, university or technical trade school.

3.0 SCHOLARSHIP PROGRAM

A. SCHOLARSHIP, AMBASSADOR AND QUEEN’S COURT COMMITTEE

3.1 The Scholarship Program will be organized and directed by the HCLE Scholarship, Ambassador and Queen’s Court Committee, hereafter referenced as *The Committee*.

3.2 A committee will be formed each year and will consist of at least one HCLE Board member and at least 3 volunteers.

B. ELIGIBILITY

3.4 Candidates must be a high school senior.

3.5 Candidates must be an active member of a 4-H Club and/or FFA Chapter in Hays County.

A. APPLICATION, RESUME, TRANSCRIPT, REFERENCE LETTERS, AND PHOTOGRAPH

3.6 Both a hard copy and an electronic copy of the completed application must be submitted.

3.7 The completed, hard copy application must contain four individual 9x12 sealed envelopes of each of the following: application form, resume, official grade transcript, three reference letters, and photograph. All aforementioned documents must be placed into a large 10x13 sealed envelope. Additionally, one copy of the entry form must be completed and attached to the front of the 10x13 envelope, with all four sealed complete packets inside this 10x13 envelope.

DO NOT place the entry form inside the application envelope.

3.8 The completed electronic copy of the application must contain a copy of each of the following: entry form, application form, resume, official grade transcript, three reference letters, and photograph. **All documents must be submitted in PDF format.**

3.12 Official grade transcripts must accompany all entries.

- a. Four signed hard copies of the candidate's official grade transcript must be enclosed in a separate, sealed envelope provided by a school official. Transcripts can be obtained at the candidate's school counselor office.
- b. Candidates will be subject to disqualification if the official grade transcript is not signed and sealed in a separate envelope by a school official.
- c. Additionally, the candidate must include a copy of his/her official grade transcript in the electronic submission.
- d. DO NOT open or scan your official grade transcript provided to you by your school official. Instead, please request an electronic PDF copy of your official grade transcript.
- e. Both formats are mandatory, though only the hard copies must be signed and sealed by the candidate's school official.
- f. Should the judges notice any discrepancy in the electronic or hard copies of the transcripts, the candidate may be subject to disqualification.

3.13 Three reference letters must be included in each candidate's application. Four copies of each of the reference letters must be enclosed within the submitted, hard-copy application. Additionally, a copy of each reference letter must be included in your electronic submission.

3.14 Four, 4x6 copies of a headshot photograph of the candidate must accompany all entries. A scanned or electronic copy of the same photograph must be included in the electronic submission.

Please ensure that the electronic copy is in PDF format. If necessary, the candidate may insert the photograph on a Microsoft Word document and save the document as a PDF.

C. PERSONAL INTERVIEW, CANDIDATES' SCORE SHEETS, AND JUDGES' COMMENTS

3.15 Prior to the personal interviews, the committee will select three judges from outside of Hays County to serve on the interview panel.

3.16 The interview date will be Sunday, October 12, 2025, at the Hays County PCT 2 Offices 5458 FM 2770 Kyle, Texas 78640

3.17 Pending extenuating circumstances, such as complications surrounding the COVID-19 pandemic, the personal interview may be conducted using alternative methods.

3.18 The duration of each personal interview with the judges' panel shall not exceed ten minutes

3.19 Each Judge on the panel shall score each candidate's application and personal interview using a standard score sheet provided by the committee. The Judges may also add comments on the score sheets.

3.20 Candidates will be judged on exhibition of highest achievements in the following areas: church, school, leadership, cooperation, character, and participation.

3.21 After the scholarship recipients have been announced, each candidate will receive a copy of their own score sheets and comments as marked by the judges.

3.22 It is intended that each candidate use his/her own score sheets and comments as a tool to learn in what areas he/she excelled and how he/she can make improvements in future applications and interviews. Score sheets ARE NOT provided so that the candidates or their parents/legal guardians may compare scores. These scores are intended for private and personal use. Please DO NOT abuse the privilege.

D. AWARDS

3.23 HAYS COUNTY LIVESTOCK EXPOSITION, INC AWARD: The Hays County Livestock Exposition (HCLE) will give multiple scholarships up to \$10,000.00. All scholarships awards will be sent directly to the schools upon proof of

enrollment in college, university, or technical trade school. All awards must be redeemed within 1 year after awards are announced.

3.24 The committee actively seeks additional scholarships. When additional scholarships are available, they will be announced.

4. EQUINE DIVISION

HORSE RULES

4.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

4.2 A Minor’s Release Form, signed by a parent or guardian, must accompany all entries.

4.3 An Affidavit of Ownership or 4-H Lease is necessary to enter grade horses. For registered horses, completed registration papers prior to November 1st through the breed registry/association will prove ownership. Transfer papers will not be accepted as proof of ownership. For registered horses that are leased, please complete the Texas 4-H Lease Horse Agreement. Papers must be submitted to the Texas A&M AgriLife Extension Office, Hays County.

4.4 Horses must be solely owned by the contestant or the contestant’s father, mother, brother, sister, grandparents, or legal guardian, or leased to a 4-H or FFA member or leased as per the Texas 4-H Lease Horse Agreement.

4.5 A contestant may enter as many horses as he or she chooses but shall enter only one per class. The contestant must designate which horse they are accumulating points on for the All-Around Awards-see 4.8(a).

4.6 Only one contestant per horse will be allowed. Sharing of horses with siblings will not be allowed. The only exhibitor substitution that will be allowed is in halter.

4.7 Proof of a negative Coggins Test, within the last twelve months, must be provided for all horses brought to compete at the Hays County Horse Show. Failure to provide such proof will result in the immediate removal of the animal from the show grounds. Paid entry fees will be forfeited.

4.8(a) There will be two All Around High Point Champion and Reserve Champion Awards in each of the Junior and Senior age divisions based on one horse/one exhibitor for the class entries. Points accumulated from all classes entered by horse/exhibitor team will count toward Champion/Reserve Champion All Around Awards. If showing more than one horse, contestants must designate which horse they are accumulating points on for

the All-Around Awards.

(b) There will be four buckles awarded at the conclusion of Halter classes for one Grand Champion and one Reserve Grand Champion in Halter Mares and Halter Geldings.

(c) There will be three buckles awarded at the conclusion of Western Showmanship at Halter classes for Grand Champion in Clover, Junior, and Senior divisions.

4.9 All Classes must be pre-entered by the deadline specified in the “General Rules”

4.10 Showmanship and riding classes will be divided into Clover kids (Kinder-2nd Grade) Junior (3rd-8th Grade) and Senior (9th-12th Grade) divisions. Grade is determined at the time of the show.

4.11 Clover kids will be allowed to do halter and showmanship but will NOT be allowed to participate in Riding Events.

4.12 All award recipients must write a thank you letter.

4.13 The arena will be dragged at the division superintendent’s discretion.

4.14 A contestant may be disqualified from a class, at the judge’s discretion, for receiving excessive instruction from outside the ring.

4.15 All contestants are asked to refrain from allowing their horse(s) to be ridden by anyone other than the exhibitor. Many of the participants have family members who will want to help hold, groom, saddle, and bridle horses in preparation for classes. This is encouraged because family involvement is an important part of the 4-H Horse Program.

4.16 For safety reasons, speed events will run back to a closed gate.

4.17 Unless otherwise stated, rules will be based on Texas State 4-H Horse Show Rules as applicable.

If a tie still exists, contestants will be named Co-Champion and duplicate Champion awards will be provided at show management expense. No Reserve Champion will be named.

4.19 Horse Program Patronage Awards

1. All exhibitors earning an award must send their sponsor/sponsors a "Thank You" letter.
2. All classes will be jackpotted based on the number of horses per class.

MARKET ANIMAL DIVISION RULES

5.0 STEERS

5.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

5.2 Steers must be halter broken, groomed, and may be shown in the hair. Cattle may be blocked; however, this will be a Blow and Show only with no painting or dyeing allowed. Animals will be disqualified from the show for violation of grooming rules.

5.3 Light oils and foams will be allowed for preparation on show day. Adhesives, glues, false hair, and coloring are NOT allowed.

5.4 Weight classes will be determined by breeds.

5.5 The following breeds will be the only breeds eligible for show. All breed classification guidelines are listed below. The classification guidelines will be provided to the classification committee for reference. The interpretation of these guidelines is at the sole discretion of the classification committee. The decision of the classification committee will be final.

5.18 All disorderly cattle will be removed from the show grounds at the discretion of the division superintendent.

5.19 The use of equine pellets are only allowed for cattle.

6.0 MARKET SWINE

6.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

6.2 Barrows and gilts are eligible. Declaration of whether the Animal shows in market or breeding will be done at check-in in as long as two entries have been paid for the animal to show in either market or breeding.

6.3 Hogs will be classified and divided by breeds. Hogs classified out of purebred classes will go into the crossbred class.

6.4 Market swine will have a minimum weight of 160 lbs. and maximum of 280 lbs. with a 10 pound + or – tolerance.

6.5 Hogs will be exhibited in one or more weight classes by breed. Weight classes will be determined by the division superintendent at check-in.

6.6 All hogs in each class will be placed.

6.7 There will be a Breed Champion and Reserve Breed Champion. They will compete for the Grand Champion and Reserve Champion of the show.

6.8 No pasting, painting, oil-based products, or powder is to be used in grooming. Only water can be used. Animals will be disqualified from the show for violation of grooming rules.

6.9 All breed classification guidelines are listed below. The classification guidelines will be provided to the classification committee for reference. The interpretation of these guidelines is at the sole discretion of the classification committee. The decision of the classification committee will be final. Classification will be done at check-in.

6.10 The use of equine pellets are only allowed for cattle.

7.0 MARKET POULTRY

7.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

7.2 If at any time from the time you receive your chicks up to showtime you have any wing band issues, do not remove the wing band. Immediately contact the Poultry Superintendent or County Agent to resolve the issue.

7.3 Broilers will be shown at approximately 45 days old.

7.4 All poultry will be sifted and classified at check-in.

7.5 As per state requirements, “orders are placed in increments of 25. A minimum order per exhibitor or family unit is 25 chicks and up to a maximum of 75 chicks. **Therefore, each exhibitor/family may order 25, 50, or 75 birds.** Each exhibitor **MAY** order an individual set of birds (up to 75) OR siblings within the same household may order and share a set of birds (up to 75). In other words a family with multiple exhibitors can order an individual set of birds for each exhibitor in the family, OR if they wish, they can order one set of birds for the entire family. In either case, the maximum number of birds in a set that an exhibitor can select from for the show is 75 birds. Families with multiple exhibitors are **NOT** required to place a single order for the entire family. Family orders are an option.” The sets will be assigned to the exhibitor or to the family by the County Agent, or their designee, when they arrive. It is the exhibitor’s responsibility to keep track of their assigned birds.

7.6 Broilers will be of the Commercial Breed with all three birds from the same hatch date. These will be ordered through

the Texas A&M Agrilife Extension Office, Hays County. The County Agent and FFA Advisors will coordinate.

- a. Each exhibitor's order will be identified by a series of numbered wing bands. Chicks are assigned to exhibitors by these numbers.
- b. Disqualifications include but are not limited to: broken or dislocated legs, broken or dislocated wings, sickly birds, etc. Disqualifications will be up to the sifter and/or Superintendent.
- c. Broilers losing their wing band, for whatever reason, will not be allowed to enter the show. Broilers with wing bands that show evidence of tampering will be sifted and the decision of the Superintendent is final.
- d. The Superintendent will instruct the sifters and judges to disregard wing bruising and damage caused by a wing band.

7.7 Broilers will be divided into two classes, Pullets (**Females**) and Cockerels (**Males**), each shown as a pen of three. If an exhibitor has a mixed pen of Cockerels and Pullets with no replacement birds to make the pen all one sex, then that pen will be shown in the Cockerel show.

7.8 There will be a Grand Champion and Reserve Champion Broiler (Pen of Three). The First Place Cockerel and Pullet will compete for Grand Champion. If the Cockerel wins Grand, Second Place Cockerel moves up to compete for Reserve. If Pullet wins Grand, Second Place Pullet moves up to compete for Reserve.

7.9 Turkeys will be shown as singles.

7.10 Turkeys will be of the Commercial Breed from the same hatch date. These will be ordered through the Texas A&M Agrilife Extension Office, Hays County. The County Agent and FFA Advisors will coordinate.

- a. Each exhibitor's order will be identified by a series of numbered wing bands. Chicks are assigned to exhibitors by these numbers.
- b. Disqualifications include but are not limited to broken or dislocated legs, broken or dislocated wings, sickly birds, etc. Disqualifications will be up to the sifter and/or Superintendent.
- c. Turkeys losing their wing band, for whatever reason, will not be allowed to enter the show. Turkeys with wing bands that show evidence of tampering will be sifted and the decision of the Superintendent is final.
- d. The Superintendent will instruct the sifters and judges to disregard wing bruising and damage caused by a wing band.

7.11 Turkeys will be divided into two classes, Hens (**Females**) and Toms (**Males**).

7.12 There will be a Grand Champion and Reserve Champion Turkey. The First Place Tom and Hen compete for Grand Champion. If Tom wins Grand, Second Place Tom moves up to compete for Reserve. If Hen wins Grand, Second Place Hen moves up to compete for Reserve.

7.13 Parents and Volunteers may assist Exhibitor during check in. Parents and Volunteers may also assist exhibitors by helping to hold poultry during show **ONLY** if no Hay County 4-H or FFA members are available to assist **AND** with Superintendent's permission.

7.14 Poultry will be released by the Division Superintendent.

8.0 MARKET RABBITS

8.1 Refer to the "General Rules" regarding all matters not listed under the specific division rules.

8.2 All recognized meat breeds of rabbits will be eligible.

8.3 The American Rabbit Breeders Association Rules will apply.

8.4 Any animal showing symptoms of disease such as buck teeth, malocclusion, broken teeth, sniffles, ear canker, mites, mange vent disease, runny eyes, missing toenails or other disqualifying features will be excluded from the show. Refer to the "Standards of Perfection" section of the ARBA rules for further details on disqualifying diseases and features.

8.5 Each market rabbit must be clearly and permanently earmarked in the RIGHT ear during validation with the designated tattoo for this show and family member.

8.6 Before Check-In, rabbits must be individually earmarked with a clear and permanent tattoo in the LEFT ear with identification letters and/or numbers.

8.7 Market rabbits that have been validated for any other county show will not be eligible for the Hays County Show.

8.8 Market rabbits are shown as either a pen or three (3) rabbits or as a single fryer (FRYER). There will be a minimum weight of 3.5lbs. and a maximum of 5.5lbs. per rabbit. There will be an allowed two-ounce tolerance per rabbit. **The age of each rabbit must not be more than 70 days old at check-in.** Exhibitors may enter a maximum of two pens and one fryer. To be eligible to enter a fryer the exhibitor must enter at least one pen. The exhibitor must therefore have validated at least 4 rabbits. An

exhibitor is not required to show a pen to show a fryer.

8.9 All rabbits will be sifted at weigh-in. The exhibitor will present their PEN and/or FRYER to be weighed and sifted. The FRYER cannot be one of the rabbits used to make the PEN. If a rabbit is disqualified the exhibitor may substitute rabbit at this time only. After the exhibitor has determined which three rabbits will constitute their PEN and which one rabbit will be their FRYER entry, only those rabbits and no others will be placed in the show holding cages until the time of the show. To aid in the show the superintendent, at their discretion, may use a permanent marker or some other means to help identify which rabbit is being used as the fryer.

8.10 There will be a Grand Champion and Reserve Champion Pen and Fryer. Market Pens are eligible to go to auction and the number shall be established by the board.

8.11 Winners of the “Fryer Show” shall be paid a premium based upon the number of entries paid by exhibitors. The amount per premium and the number of premiums to be paid shall be determined by the board prior to the show.

9.0 MARKET LAMBS

9.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

9.2 Wether and ewe lambs are eligible. Declaration of whether the animal shows in market or breeding will be done at check-in as long as two entries have been paid for the animal to show in either market or breeding.

For clarification, this means that a paid market entry AND a paid breeding entry are required in order to have a choice at Check-in. It does NOT mean that a single animal can show in both classes.

9.3 All lambs will have a minimum weight of 90 lbs., except Southdowns and Dorpers which have a minimum weight of 80 lbs., but with a 5 pound + or – tolerance.

9.4 Lambs will first be divided into Fine Wool, Fine Wool Cross, Medium Wool, and Southdown breeds, and Dorper. A Fine Wool Cross must be the first cross between a Fine Wool and a Medium Wool breed. All sheep will be classified at Check-In and decisions of the classifiers will be final.

9.5 Lambs will be divided into one or more weight classes by breed: Southdown, Dorper, Fine Wool, Fine Wool Cross, and Medium Wool.

9.6 Weight classes will be determined by the division

superintendent after weight cards have been received at Check-In.

9.7 All lambs will be slick shorn at time of arrival on the show grounds. Leg sheering is optional.

9.8 There will be a Breed Champion and Reserve Breed Champion. They will compete for the Grand Champion and Reserve Champion of the Show.

9.9 No painting or dyeing will be allowed. Water or waterless shampoo is allowed. Animals will be disqualified from the show for violation of grooming rules.

9.10 All lambs must stay in their assigned pen in the show barn and may not be kept or put into trailers or outside pens

9.11 All breed classification guidelines are listed below. The classification guidelines will be provided to the classification committee for reference. The interpretation of these guidelines is at the sole discretion of the classification committee. The decision of the classification committee will be final.

9.12 The use of equine pellets are only allowed for cattle.

For clarification, this means that a paid market entry AND a paid breeding entry are required in order to have a choice at Check-in. It does NOT mean that a single animal can show it in both classes.

10.3 Market Goats will be weighed in with a minimum limit 60 lbs. and maximum limit 120 lbs. with a 5 pound + or – tolerance.

10.4 Weight classes and divisions will be determined by the division superintendent after weigh cards have been received at Check-in.

10.5 Market Goats must be taught to lead and should be shown with a collar or halter.

10.6 All Market Goats must be slick shorn at the time of arrival. Leg shearing is optional.

10.7 Market Goats must be dehorned or tipped to achieve a blunt end.

10.8 The First and Second Place of each class will compete for Champion and Reserve Champion of their division. Division Champions will compete for the overall Grand and Reserve Champion.

10.9 The use of talc. Oils, or any foreign material is prohibited. Water or waterless shampoo is allowed. Animals will be disqualified from show for violation of the grooming rules.

10.10 All goats must stay in their assigned pens in the show barn and may not be kept or put into trailers or outside pens.

10.11 The use of equine pellets is only allowed for cattle.

BREEDING ANIMAL DIVISION RULES

11.0 BREEDING BEEF CATTLE

11.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

11.2 Eligible heifers may be purebred, crossbred, or miniature. Heifer classes will be broken by entries into respective classes in order of judging.

12.2 Bucks are not eligible to compete.

12.3 The show is open to any breed or crossbred.

12.4 The age of the animal will be computed as the age at check-in

12.5 Shearing is not required.

12.6 The use of equine pellets is only allowed for cattle.

12.7 Classes will be as follows.

14.4 No pasting, painting, oil-based products, or powder is to be used in grooming. Only water can be used. Animals will be disqualified from the show for violation of grooming rules.

14.5 The use of equine pellets is only allowed for cattle.

15.0 BREEDING RABBITS

15.1 Refer to the “General Rules” regarding all matters not listed under the specific division rules.

15.2 All recognized breeds of rabbits will be eligible. The American Rabbit Breeders Rules will apply.

15.3 During validation, each rabbit must be clearly and permanently earmarked with an individual tattoo in its left ear and a validation tattoo in its right ear. Previous validation or ARBA tattoos in the right ear will suffice as a validation tattoo as long as they are clearly legible. All rabbit entries must include ear number, class, sex, and breed.

15.4 The breeding show will be a carrying cage show. Breeding rabbits will arrive the same day as judged. Exhibitors will furnish their own carrying cages.

15.5 Breeding rabbits check-in will be on January 19, 2026 by 12:00 noon. The exhibitor will complete and turn in a completed show card to the superintendent by that time to be entered. This card must match the validation card for this rabbit previously submitted at validation. The rabbit will then be called up for exhibition once the breeding rabbit show begins.

15.6 Classes are as follows:

16.3 Schedule***All entries must be checked out. Any entries not picked up before 5:30pm will be taken to the Hays County Extension Office. You will need to make arrangements with that office for pickup.**

16.4 Hays County Livestock Expo, Inc. (HCLE) or its designated workers, leaders, or supervisors are not responsible for items entered in the show. Every effort will be made to protect items from damage or theft, but valuable items should not be entered or should be insured.

16.5 Participants are divided into 4 grade groups.

16.6 All items must have been made by the participant since the previous year’s show. When making Home Skills projects, participants may only utilize minimal assistance from others.

16.7 An entry fee of \$10.00 per item will be charged.

16.8 Each participant may enter up to 2 entries per class. Participants may not change entry classes once entries are submitted. Entries may not have the participants name on the entry or any other recognizable identifying markings. Entries are to remain anonymous to the judges.

16.9 Entries will be checked in between 5:00 pm and 7:00 pm on Monday of the show. **No items will be accepted for check in after 7:00 PM on the Monday of the show, No Exceptions.** Each food item must have a “Baked Food Recipe Form” or “Preserved Food Recipe Form” attached. All other items must have an “Arts, Crafts, and Clothing, Photography, or Horticulture Form” attached. Forms are available from the HCLE website and your advisor. Names of participants will be covered during judging. No additional information may be attached to any entry. The Home Skills Superintendent will have final decisions on division and class placement for each entry.

16.10 The decisions of the judges are final. Questions concerning entries during judging will be resolved at the judge’s discretion. Following judging, all items must remain in the Home Skill area until check out on Tuesday afternoon. The Hays County Livestock Board of Directors reserves the right to disqualify or alter results in cases where suspicion of dishonesty may arise.

16.11 Awards

16.12 Grand Champion and Reserve Champion awards will be given to the top entries in each category (a. Foods, b. Arts, Crafts, & Clothing, c. Photography and

d. Horticulture). The same exhibitor MAY NOT win both Grand and Reserve Champion in the **SAME** category. Grand Champion and Reserve Champion will sell in the auction.

16.13 A Sweepstakes Award will be given to four (4) contestants (one in each age group) who accumulate the largest number of points within his/her age group.

If the score in the sweepstakes contest is tied, the participant with the most blue ribbons will be declared the winner. If two participants are tied in points and have the same number of blue ribbons, the award will go to the participant with the most entries.

16.14 Check-out of projects will be Wednesday from 1:00pm-5:30pm. Premium money will be distributed to Participants based on points (see Rule 16.14). Premium money will not be given to Grand or Reserve Champion since these projects are eligible for the auction.

17.0 FOODS

Note: There are two classes of food entries, A-Baked Foods & B-Preserved Foods.

A. BAKED FOODS

In addition to entry forms and fees, you must also submit your recipes on the “Baked Foods Recipe Form” available on the HCLE website or from your advisor. Please keep a copy of your Baked Food Recipe Form(s).

17.1 All food entries must be prepared from scratch. Pudding mix is the only type of mix allowed in the preparation. Cake mixes are not allowed for any portion of the project.

17.2 Commercial bread making machines or any other appliance which prepares a product without using standard preparation procedures are not allowed.

17.3 All pie crusts must be made from scratch and must include the recipe for the pie crust itself.

17.4 If a recipe calls for a biscuit mix, such as “Bisquick”, the contestant must make a homemade version.

17.5 Participants must submit a whole or complete recipe, including ingredients, measurements, and instructions, for each

of their food entries, and then prepare and bring those whole or complete recipes at check-in.

17.6 Only edible garnishes are allowed.

17.7 After Check-in, all food items and their recipes become the property of the HCLE Board.

17.8 A “Baked Food Recipe Form” must be attached securely on the top of the plastic container, taped on one edge for viewing, but not obstructing the view of the product.

17.9 To ensure food safety, since refrigeration is not available, no uncooked foods are allowed. Examples include, but are not limited to, milk (up to 2 tablespoons allowed), half and half, cream, cream cheese, yogurt, whipping cream, egg or egg substitute. Food requiring refrigeration after baking is not accepted. Examples include, but are not limited to, cheesecakes, lemon bars, ganache or pudding type fillings, cream pies and fillings, pumpkin pies, custards, whipped toppings, cream cheese icings and fillings, meringue, or cakes with a high moisture content. If further clarification is needed concerning this rule, please contact the Home Skills superintendent. The Home Skills Committee will review recipes and will contact participants if any of their recipes are unacceptable. Participants will then have until the fourth Monday in December to submit a new recipe (must be within the same class) to the Home Skills Superintendent for approval. No new recipes or substitutions will be accepted after the fourth Monday in December.

17.10 Food items will be exhibited in clear plastic containers (like ones from a bakery), and a sample from each entry (one cookie, roll, piece of cake, etc.) must be removed from the item and sealed separately in a zipper bag or cling wrap. The sample should then be placed on a small disposable plate and sat on top of the container so that the judges can taste without having to disturb the container.

In addition to entry forms and fees you must submit your recipe on the “Preserved Foods Form” available on the HCLE website or from your advisor. Please keep a copy of your “Preserved Recipe Form(s)”

18.1 Kits are not allowed. Kits are defined as packages of pre-cut or pre-finished materials that have all the supplies to finish a

project in the package.

18.2 All clothing must be on hangers. All items must be clean, pressed, and undamaged to be accepted. Items should be covered with clear plastic bags.

18.3 Metal or Wood Projects shall be no more than 2ft. x 2ft. x 2ft. **If larger than 2ft.x 2ft. x 2ft. the project will be disqualified.**

18.7 There will **NOT** be any electrical outlets available for exhibitors to connect to. Battery power will be acceptable.

19.0 PHOTOGRAPHY

In addition to entry forms and fees, you must also submit a description of your project on the “Arts, Crafts, & Clothing, Photography or Horticulture Form” available on the HCLE website or from your advisor at check in.

19.1 All photographs must be 8”x10” in dimension. Permanently flush mounted on a thin foam board the same size as the photo (8” x 10”) without any additional frame or mat. Masonite, photo folders, corrugated cardboard or poster board is not acceptable. No other sizes will be accepted. Photographs

must not be framed. All photographs must have been taken by the contestant since the previous year’s show.

19.4 The same exhibitor may not win both Grand Champion and Reserve Champion Photography.

20.0 HORTICULTURE CATEGORY

In addition to entry forms and fees, you must also submit a description of your project on the “Arts, Crafts, & Clothing, Photography, or Horticulture Form” at check-in available on the HCLE website or from your advisor.

20.1 While exhibitors are not required to take Horticulture or Floral Design Classes, projects exhibited must have been constructed by the 4-H, FCCLA or FFA member during the year since the previous show. All projects must be made available to the ag teacher or 4-H leader at any time.

20.2 Each exhibitor may enter a maximum of two projects. The projects can be exhibited only one time at the Hays County Livestock Show.

20.3 Exhibitors may not assemble the projects in the check in room. All projects must be finished at the time of check-in. (paint, varnish, water shed, weatherproof etc.) Only dead or dying live flowers may be replaced after check-in.

20.4 Entries may be Fresh Flower Arrangements, Dish Gardens/Terrarium, Potted Plant, or Silk Floral Arrangement. Exhibitors may not change the class of their project at check-in, even if that means the class is now incorrect. All projects in incorrect classes will be disqualified.

20.5 Entries must not exceed 2ft x2 ft.x2 ft. in size and must weigh no more than 30 lbs. **If larger than 2ft x 2ft x2ft the project will be disqualified.**

20.6 Plants must be free of insects and disease. Leaf polish or other commercial foliage enhancers are not permitted.

20.7 Plants must be watered prior to entry and maintained during the show.

20.8 There will **NOT** be any electric outlets available for exhibitors to connect to. Battery power will be acceptable.

20.9 The HCLE will not be held responsible for lost, damaged or dead items. Small items, accessories, etc. should be securely fastened to their container. Items of great sentimental value should not be used. Any entry that does not comply with all competition rules will be disqualified.

AGRICULTURAL MECHANICS DIVISION

21.0 AG. MECHANICS

21.1 Schedule21.2 An entry fee of \$20.00 will be charged for each project.

21.3 Projects must have been constructed by FFA, FCCLA, and

4-H members either as a part of their agricultural mechanics instruction in vocational agriculture or as a part of their supervised work experience program.

21.4 A project can be exhibited only one time at the Hays Livestock Show and must have been constructed within one calendar year of the exhibition date.

21.5 All projects must be painted or properly treated and must be clean and in a presentable condition even though they may have been used.

21.6 A working plan, drawing, and photographs showing construction and a bill of materials is required with each project.

21.7 Projects may have been individually, or group constructed and may be individually or chapter owned.

21.8 All projects must be complete and finished by 7:00 pm on Sunday, January 19, 2025, or be disqualified.

21.9 Every precaution will be taken to protect the projects, however, neither the HCLE Board of Directors nor the officials of this Division will be responsible for any losses or damage to projects.

21.14 Each Division will have a Grand and Reserve Champion who will be eligible to compete for Group Grand and Reserve Champion.

21.15 All Group Grand and Reserve Champions will compete for Overall Grand and Reserve Champion of the Ag Mech Show.

21.16 Blue Quality Group Grand and Reserve Champions will receive belt buckles and will be eligible for the auction. Ownership of the projects will be retained by the exhibitor.

21.17 Exhibitors may offer their project for sale by placing a “For Sale” sign and a price on the project. It may be necessary to move the project to a designated area during auction, at the discretion of the superintendent or the HCLE Board.

21.18 Kits are not allowed. Kits are defined as packages of pre-cut or pre-finished materials that have all the supplies to finish a project in the package.

21.19 Exhibitors should be prepared for an interview by the judge. They may be asked questions concerning, but not limited to, project construction, design, use, operation, etc. Exhibitors may be asked to demonstrate all or part of the project operation.

21.20 All classifiers and judges’ results are FINAL.

AUCTION

22.0 SALE RULES

22.1 This will be a ribbon sale with ownership of the animals and projects retained by the exhibitor except for food items which will be claimed by the buyer.

22.2 An exhibitor may sell one unit per division, with a maximum of two units across different divisions, in the auction. The only exception to this is if he or she has a Grand Champion and/or Reserve Champion in more than two divisions. As an example: to sell more than two items, the exhibitor must have more than two Grand or Reserve Champions in different divisions. Grand and Reserve Champions in breeding classes will be eligible to sell.

22.3 A “Unit” will be defined as follows:

22.4 Each exhibitor must appear in the auction ring with his or her own animal for the sale unless otherwise authorized by the HCLE Board of Directors. Only the Grand Champion, Reserve Grand Champion, Breed

22.5 Buyer appreciation gift/gift baskets are allowed, but not required.

22.6 Exhibitors are not permitted to solicit buyers at the sale.

22.7 All exhibitors will be assigned a sale lot number.

22.8 Only the exhibitor will be allowed to enter the sale ring. Should the exhibitor need assistance, there will be a member of the Queen’s Court/Ambassadors available. one hour after the *sale*.

22.9 Only the exhibitor, buyer(s) and a member of the Queen’s Court will be allowed in the buyer’s photo.

22.10 All auctioned items will be assessed a 10% commission charge.

22.11 No floor price will be available for those animals not making it into the auction.

22.12 Each exhibitor will be responsible for the removal and return home of their own animals after the show. A \$25.00 handling fee will be assessed to exhibitors who do not remove their animals. All animals will be removed Champion, and Reserve Breed Champion projects are allowed to be present at the auction.

22.13 The HCLE Board of Directors will determine the number of projects to be sold and the order of the sale prior to the auction.

22.14 Any exhibitor going through the auction must send each buyer a “Thank you” letter. Pictures and buyer’s lists will be sent to the 4-H Club Managers, FFA, and FCCLA Advisors as soon as possible after the show. Buyers “Thank you” letters must be addressed, stamped, and delivered to the 4-H Club Managers, FFA, and FCCLA Advisors before checks are distributed. One photo must be sent to your main buyer. Additional photos may be purchased from the photographer.

22.15 All “add-on’s” must be submitted to the treasurer within two (2) weeks after the current year’s auction.

22.16 The HCLE Board of Directors will assess 1.5% interest per month to all outstanding invoice balances that are not paid within 90 days after the current year’s auction.
