

**AMELIA VILLAGE, OHIO
ORDINANCE: O-2014-04**

**AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE, OHIO AMENDING
ORDINANCE O-2013-61 MAKING SUPPLEMENTAL APPROPRIATIONS FOR
CURRENT EXPENSES & OTHER EXPENDITURES FOR THE FISCAL YEAR ENDING
DECEMBER 31, 2014 FOR AMELIA VILLAGE.**

WHEREAS, the Village is required by statute to prepare and adopt annual permanent appropriations of Village revenues for current expenses and other expenditures for the fiscal year ending December 31, 2013;

WHEREAS, on December 17, 2013 the Village Council adopted O-2013-61 authorizing the Temporary Appropriations for current expenses and other expenditures during fiscal year 2014; and

WHEREAS, an error was contained in said Ordinance and needs to be corrected.

NOW THEREFORE BE IT ORDAINED by the Amelia Village Council as follows;

SECTION I It is necessary to amend Ordinance O-2013-61 as an incorrect amount was recorded as an appropriation during the year ending December 31, 2014, the corrected following amounts be and they are hereby set aside and appropriated as follows:

SECTION II That there be appropriated from the Parks & Recreation Fund:

SECTION III That there be appropriated from the Tree Fund:

SECTION IV Village Council finds these supplemental appropriations are necessary to provide sufficient funds for the several obligations of the Village.

SECTION V the Village Fiscal Officer is hereby directed to make the temporary appropriations as outlined in this Ordinance.

SECTION VI This Ordinance shall take effect and be in force at the earliest time allowed by law.

SECTION VII Village Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
