- **Water Line Repairs, 40% of the time**
Performs unskilled, semi-skilled and skilled tasks to assist with all aspects of installation and repairs to the water distribution system.
- **Equipment Operation, 20% of the time**
Operates bobcat and various small equipment.
- **Yard Restoration, 20% of the time**
Performs mechanical or hand preparation of disturbed ground; applies seed/straw; and plants shrubs and trees, etc.
- **Hydrant Work, 10% of the time**
Performs preventive maintenance on hydrants; and repairs and replaces broken hydrants.
