Quote sheet for mowing the Rome City Dam: embankment, spillway area and Sycamore Park for the year 2019. See Attached Map showing area to be mowed.

- 1) Mowing of park area (west of St. Rd. 9); Sycamore Park and North Street (to the edge of the gravel) and the earthen embankment (east of St. Rd. 9); to include both sides of the gravel roadway to water's edge where possible. This bid should include trash removal (i.e. litter) prior to mowing. Must have commercial equipment capable of handling the steep slope mowing. The grass in Sycamore Park to be cut to three-four inches. The rest of the area to be cut to five-six inches. FYI: grass must be cut often enough that no clippings are left after mowing.
