

ORDINANCE NUMBER 12

AN ORDINANCE OF THE TOWNSHIP OF MARION, CENTRE COUNTY, PENNSYLVANIA, REGULATING VEHICULAR TRAVEL IN THE TOWNSHIP BY IMPOSING CERTAIN WEIGHT LIMIT RESTRICTIONS ON CERTAIN TOWNSHIP ROADS AND BRIDGES; PROVIDE FOR POSTING OF SIGNS INDICATING SUCH WEIGHT LIMITS; AND PRESCRIBING PENALTIES FOR VIOLATION.

BEING inacted and ordained by the Township of Marion it is hereby enacted and ordained by authority the same as follows:

1. Pursuant to the authority vested in the Township Supervisors by the Motor Vehicle Code of the Commonwealth of Pennsylvania, and by the request of the Commonwealth of Pennsylvania, Department of Transportation as a result of engineering studies and by authority of Section 201.81 of Title 67-Section 4902(a) of PVC, the following weight restrictions are imposed upon the designated highways and bridges of the Township.

2. On the following bridges, streets or parts of streets, by authority granted by Section 4902(a) of the Vehicle Code it shall be unlawful for any person or persons to drive any vehicle or combination having a gross weight in excess of the maximum prescribed below for that bridge or street or part of street, as the case may be:

3. The appropriate employees of the Township shall post legal signs as required by law indicating the exceeded weight restrictions.

4. Any person who violates any provision of this section shall be prosecuted under Sections 4902(a) and 4902(g-1) of the Vehicle Code, and, upon conviction, shall be sentenced to pay a fine of one hundred fifty dollars (\$150.00) plus one hundred fifty dollars (\$150.00) for each five hundred (500) pounds, or part thereof, in excess of three thousand (3,000) pounds over the maximum allowable weight, and costs. In default of the payment of such fine, the defendant may be sentenced and committed to the County Jail for a period not exceeding 30 days.
