Destiny-Gram was born as a significant innovation in the personal development space, predominantly designed for students and young professionals, combining philosophical depth with cutting-edge AI technology. From its origins in Greg Malpass's personal reflections and literary works during the COVID-19 pandemic to its evolution into a sophisticated AI-driven platform, Destiny-Gram demonstrates the powerful potential of integrating human wisdom with artificial intelligence. The following reports and book sample track Destiny-Gram's development from literary conception to technical implementation:



Early Literary Works



The platform incorporated sophisticated proprietary elements from its foundational literary works, all integrated into a comprehensive AI-driven analysis and progress tracking system. The technical architecture is fully specified, with complete documentation of all system components, integration requirements, and implementation protocols. The following paper maps the architecture and online experience, and the YouTube video give an overview of the “Personal Profiling and AI Mentoring” concept:



Independent Assessment by AI-Platforms themselves valued the Pre-MVP IP at between **£1m-£2.5m**, and underwrote the project's potential and initial revenue projections of £35M within 5 years (now enhanced to £175M)


A full Business Operational Framework was developed delivering secure 60% enhanced AI-responses, without Premium Costs:




The key problem (Data Security) was soon identified as: “The AI Personalization Paradox” - AI systems require personal data to provide meaningful guidance, but current approaches harvest user information through surveillance capitalism. 78% of users want personalized AI experiences, yet 82% express concern about how their data is collected and used (Gartner/McKinsey research). Changes in the AI market (viz. X-x.ai) were exacerbating these concerns. Destiny-Gram was to establish its Privacy Protocol.




The Destiny-Gram Model was up-dated and re-coded to fully address these concerns:


The concept of “Constitutional Memory” was born and considered best targeted at Anthropic Claude, given its ‘Constitutional-AI’ strong security ethos, at the time:



The Destiny-Gram Product was re-branded as Constitutional Memory .ai:

Constitutional Memory.ai mission is to be the ‘Universal Identity and Trust layer for AI chatbots and Enterprises’, offering a solution to the ‘memory liability’ posed by AI companies and their enterprise clients holding users’ personal data and information. AI companies currently ‘harvest data’ and use conversation history which lacks structured, comprehensive user understanding. ‘Opting Out’ of their data sharing/chat-history features only destroys the personalisation sought by users. Constitutional Memory.ai creates user-controlled detailed encrypted structured personal profiles and context analysis of chat history across multiple AI-platforms for anonymised AI-chats and secure hyper-personalised responses using AI analysis and API Middleware.

Destiny-Gram’s “black box” sends personal profiles and chat history anonymously to AI chatbots via APIs



It was further recognized that different users face different versions of the same “AI Personalization Security Paradox” crisis:

- Students want academic guidance without institutional surveillance
 - Professionals need career AI enhancement without employer oversight
 - Enterprises require employee/user productivity without liability exposure
 - Families seek safe AI for children without platform exploitation
- One surveillance model cannot serve four fundamentally different privacy needs.


“The Final Solution”

“Universal Protection Model with Context-Specific Privacy- Constitutional Memory.ai will act as a sealed, anonymized vault that stores users’ profiles and chat history across AI platforms – but implements four different privacy architectures depending on user context.”

Constitutional Memory.ai will create secure, user-owned profiles that bridge individuals and AI systems with complete transparency and consent—architected differently for each market's unique requirements; while maintaining “Universal Foundation Across All Products”:



- **Zero Data Harvesting:** No automated collection—users govern all data sharing decisions
- **User-Built Profiles:** Individuals explicitly create profiles using structured assessments tailored to their needs
- **Selective Sharing:** Users control exactly what information AI systems access via secure API
- **Cross-Platform Integration:** Works with Claude, GPT, Co-Pilot as universal personalization layer
- **Constitutional Memory:** Ethical alternative to surveillance-based AI personalization- All personal data and chat history analysed, stored and controlled by the user.




One proposed management structure, and potential equity share for an “executive partner”:
