

Town of Stratton
Selectman's Meeting
October 27, 2025

Present: Selectman: Chair – Al Dupell, Larry Bills, Chris Liller, Greg Marcucci and Boomer Walker; Clerk, Kent Young; Treasurer – Alyson Peterson.

7:30 pm: Al Dupell called the meeting to order. Orders were reviewed and signed. No modifications were made to the agenda.

Employee Health Care: Alyson Peterson was present to discuss potential changes to the Health Care packages offered to employees and the renewal of the HRA policy for the Town. **Medicare Supplement Plans:** Due to recent Medicare changes, the board considered offering supplemental plans for Medicare recipients. Following the discussion, the board agreed to offer BCBSVT's Vermont Blue Medicare Supplement (Plan F) to employees who qualify and need said supplement. Said expenses to the employee for coverage are stipulated by the Town's Personnel Policy. Chris Liller so moved. Boomer Walker seconded – all concurred. **HRA Renewal:** The Board agreed to maintain current HRA benefits offered to employees, based on the 2026 rates. Larry Bills so moved. Boomer Walker seconded – all concurred. Following the discussion, Alyson Peterson left the meeting.

Town Forest - Executive Session: Boomer Walker moved to enter Executive Session to discuss ongoing litigation regarding the Town Forest. Larry Bills seconded. All concurred and the Board entered Executive Session at 7:41pm. The Chair invited Clerk, Kent Young to attend the session.

At 7:45pm, Larry Bills moved to exit Executive Session. Boomer Walker seconded – all concurred. The session ended with no decisions made.

Road Crew Issues: Chris Liller reported on the following issues: 1) **Line-Striping issue:** On Friday, the State stiped Pikes Fall Rd.. Apparently, this was followed by heavy rain that caused the paint to run into the lanes. Multiple vehicles apparently were splattered with paint and are seeking reparations. He and the Town Office will direct those involved to the State and the line-striping company. 2) **Green Mountain Power Project:** Problems with Willis Cemetery Rd. are currently being corrected by GMP's contractor. Their work on Strat.-Arl. Rd. also continues. The Road Foreman also has requested that GMP move their staging area at the Town Garage before snowfall. The Board concurred. 3) **Paving:** Chris Liller stated that Fuller Sand and Gravel, Inc. will move in the do the bridge on Canedy Rd. tomorrow (10/28/2025), followed by patch-paving over the West Jamaica Rd. culvert which was recently replaced and then they will pave the bottom section of Penny Ave., as previously determined. 4) **the New Town Truck:** Said truck should be completely ready for the Town by the end of November.

Town Generators: The Board reviewed and approved the annual maintenance contract for said generators with Powers Guaranteed Services. Boomer Walker so moved. Larry Bills seconded – all concurred and the Chair signed the agreement.

Minutes: Greg Marcucci motioned to approve the Selectman's minutes of October 14, 2025. Larry Bills seconded – all concurred.

Adjourn: Larry Bills motioned to adjourn at 7:55pm. Boomer Walker seconded – all concurred and the meeting adjourned.
