LEVEL 1 CERTIFIED CHRISTIAN LIFE COACH:

LEVEL 1: Certified (Advanced) level:

-Documented: 1 year of ministry and leadership experience. Documentation should come from your church or Christian organization.

- Complete the Certification training course; unless waived by prior documented training and experience. Course curriculum and documented experience must be provided to, and accepted by, FACCT.

-Documented: 4 years in the coaching field.

-Provide a criminal background check that has been done in the past 12 months.

Ministry documentation should be provided by your church. Bible education can be documented through Bible study; Sunday School; Bible certificates of training.

LEVEL 2 CERTIFIED CHRISTIAN LIFE COACH:

Level 2: This is an Intermediate Christian Life Coach Training Course.

Requirements: 1 year of documented:

-Ministry and leadership experience. Documentation should come from your church or Christian organization.

-Bible education; 1 character reference letter from your church.

-Complete the Certification training course; unless waived by prior documented training and experience. Course curriculum and documented experience must be provided to, and accepted by, FACCT.

-Provide a criminal background check that has been done in the past 12 months.

Ministry documentation should be provided by your church. Bible education can be documented through Bible study; Sunday School; Bible certificates of training.

LEVEL 3 CERTIFIED CHRISTIAN LIFE COACH

Level 3: Certified (Basic) level:

-Documented: 1 year of ministry and leadership experience. Documentation should come from your church or Christian organization.

-Documented: 1 year in the coaching field.

--Provide a criminal background check that has been done in the past 12 months.

General information for all fields of certification:

1. Confidentiality is paramount. All confidentiality laws or statutes must be adhered to according to the resident/practice state or jurisdiction of the Christian Life Coach. All Christian Life Coaches should research their jurisdiction's statutory requirements and/or limitations for confidentiality. Absolute confidentiality cannot be assumed to exist due to the title "Life Coach."
2. Minimum levels of training and experience are held by all Christian Life Coaches. However, a desire for ongoing, specific training should also be the goal of all who serve in this role.
3. Self-care is important. Learn principles of self-care and practice them often. "Taking care of others is noble; taking care of yourself is necessary." Do not neglect the needs of your time and presence within your own family. A Christian Life Coach feels a call to serve those in need; but that does not require a Christian Life Coach to surrender their own family and lose them as a casualty of ministry in the process.
4. At a minimum, along with general spiritual and Biblical knowledge and experience, the ability to recognize signs, symptoms, and mitigation principles in the areas of stress management and suicide awareness should be foundational for the Christian Life Coach.
5. No Christian Life Coach has to surrender their core faith beliefs to be able to serve everyone. However, compassion has no theological boundary (Jude 22). Caring for someone in the role of a Christian Life Coach may mean that the Christian Life Coach's role will be to find someone within the person's own faith system to help them.
6. The purpose of the Christian Life Coach is not to build a personal ecclesiastical body or church but to assist with coaching an individual or group to move from where they are, to where God wants them to be. Hope is what a Christian Life Coach can, and should, offer.
7. Christian Life Coaches come alongside to support, encourage and empower all people to think through their difficulties and desires. With the help of the Holy Spirit and the client, to develop a course of action.
8. Trust and respect are established over time and cannot be demanded or forced.
