

Bloomfield Police Department

Monthly Report for July 2019

This is the monthly report for the Month of July 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Monday, July 1st at approximately 10:12pm officers responded to the 1400 block of Jasmine Rd. for a disorderly conduct complaint. At the conclusion of the investigation charges of battery and disorderly conduct were forwarded to the Walworth County District Attorney's office for a 27-year-old female who had fled the scene prior to officer's arrival.

On Wednesday, July 3rd at approximately 5:44pm officers responded to the 1100 block of Poinsettia Rd. for a disorderly conduct complaint. At the conclusion of the investigation a 44-year-old female was arrested and confined in the Walworth County Jail. A charge of bail jumping has been forwarded to the Walworth County District Attorney's office.

On Friday, July 5th at approximately 6:46pm officers responded to the 2400 block of Lincoln Dr. for a disorderly conduct complaint. At the conclusion of the investigation a 25-year-old female was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and criminal damage to property have been forwarded to the Walworth County District Attorney's office.

On Saturday, July 6th at approximately 10:20am officers responded to a two-vehicle personal injury crash in the area of Hwy 50 and Eastside Road. A 19-year-old female was transported to an area hospital for treatment of non-life-threatening injuries. At the conclusion of the investigation a 50-year-old male driver was issued a traffic citation for automobile following too closely.

On Monday, July 8th at approximately 7:02pm officers responded to the 900 block of Iris Ave. for a bail jumping complaint. At the conclusion of the investigation a 32-year-old male was arrested and confined in the Walworth County Jail. A charge of bail jumping has been forwarded to the Walworth County District Attorney's office.

On Monday, July 8th at approximately 11:44pm officers responded to the 1100 block of Park Rd. for a report of a fight in progress. At the conclusion of the investigation a 41-year-old male was arrested and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office.

On Wednesday, July 10th at approximately 3:04pm officers responded to the 1200 block of Pell Lake Rd. for a disorderly conduct complaint. At the conclusion of the investigation a 50-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense.

On Monday, July 15th at approximately 11:50am officers responded to Trinity Lutheran Church W775 Geranium Rd. for a criminal damage to property complaint. Upon arrival officers were informed that three vehicles which had been parked in the parking lot had damaged windows. This incident remains

under investigation ~ anyone with information surrounding this incident should contact the Bloomfield Police Department.

On Sunday, July 21st at approximately 1:18am officers responded to the 1200 block of Laurel Rd. for a trespassing complaint. At the conclusion of the investigation a 27-year-old male was arrested and confined in the Walworth County Jail. A charge of criminal trespass to dwelling has been forwarded to the Walworth County District Attorney's office.

On Thursday, July 25th at approximately 10:40pm officers responded to the 800 block of Eau Claire Rd. for a disorderly conduct complaint. At the conclusion of the investigation a 31-year-old female was arrested and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office.

On Saturday, July 27th at approximately 7:31pm officers responded to Pioneer Estates, N2020 Hwy H for a report of a hit & run property damage only crash. At the conclusion of the investigation a 55-year-old female was arrested for operating a motor vehicle while intoxicated. Additionally, the driver was also issued a citation for unsafe backing.

On Saturday, July 27th at approximately 9:24pm officers responded to the area of Hwy H and Clover Rd. for a two-vehicle property damage only crash. At the conclusion of the investigation a 58-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense.

During the month of July 2019, the police department affected 177 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 162 arrests during the month of July 2018.
