Tuition is calculated on a yearly rate but is broken into 9 monthly payments for your convenience. The school year runs September thru June. September's tuition is due with registration and covers 1/2 Sept & 1/2 June. Tuition is due the first of every month for October – May. If registering late 1/2 months tuition is due to cover June. Any accounts 7 or more days past due will incur a \$10. late fee (per month) and this will be applied to each account. Tuition is nonrefundable and there are no credits. If withdrawing from a class, tuition will be due from date of withdrawal and priced at the single class rate not to exceed the monthly tuition and June's portion will be forfeited. If withdrawing after committing to the recital, one month's tuition will be due as an early withdrawal fee.

In attending Step by Step Studio of Dance Inc., taking dance, acro or exercise classes and otherwise using the facilities and equipment therein, or taking virtual classes, I do so at my and/or my child's own risk.
