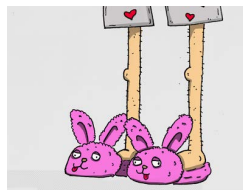

Do Not place on front porch, Do Not knock on door, Do Not ring doorbell. Do Not enter property before 11:00. If multiple exhibitors are present observe covid distancing, Thank You so much!**

**ENTRIES CLOSE Friday, June 4th 5:00 PM (MST) OR WHEN LIMITS HAVE BEEN REACHED** at the address of the Trial Secretary, after which time entries cannot be accepted, canceled, or changed, except for as provided in Chapter 1, Section 16 of the AKC Obedience Regulations. All entries, including wait listed entries, must be received by the trial secretary prior to June 4th 5:00 PM.

Bitches in season: A written request (email notification is acceptable with return email receipt verification from the secretary) is required to receive a full refund and the request must be received by the Trial Secretary no later than 24 hours prior to the start of judging.

WAIT-LIST: A wait-list (**5 entries**) will be maintained in order to fill openings created by entries that are withdrawn prior to the event closing day. The full entry fee will be refunded to an entrant whose entry is replaced by a wait-listed entry. Wait-listed entries must be received by the trial secretary prior to closing date and will be first received entry method.

Any wait-listed entry that does not move off the wait-list into the trial will receive a full refund, entry form and method of payment shredded. If partial entries move in a refund will be issued for entries that did not move in.

### **Entries will be refunded if the show is canceled due to COVID 19.**

Illegible entries will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3). Dogs listed in the AKC Canine PartnersSM Program should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants. ### **ADDITIONAL TRIAL RULES**

MAIL or DROP OFF - To be acceptable, submit entry, with the required entry fee, on an official AKC entry form, or copy, including the agreement and instructions. Please type or neatly print.

A recording fee of 50 cents per first entry of each dog and Event Service Fee of \$3.00 per entry is required for each dog entered at any Licensed or Member Club Show or Obedience Trial.

This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the recording fee is to be collected on the first entry only Ch. 11, Section 2, AKC Dog Show Rules.

- The club assumes no responsibility for a wrong entry.
- Entries without fees cannot be accepted. Entries specifying any condition as to acceptance cannot be accepted. Unsigned, incomplete, telephone, fax or email entries will not be accepted.
- The owner is responsible for errors on entry forms, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors. No dog wrongly entered in a class may be transferred to another class after close of entries. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Changes by telephone are not acceptable.
- Entries will receive an email confirmation within 7 days after receipt, if an email address is provided on the entry form, otherwise, the confirmation will be sent via USPS standard mail. If acknowledgments are not received by an exhibitor 7 days prior to the Trial, please notify the Trial Secretary.
- Consult Judging Schedule for time of judging.
- Exhibitors and handlers alone are responsible for the presence of their dogs in the judging ring.
- The Club and the Trial Secretary assume no responsibility in this regard.
- The Club will exercise every precaution for the safety of dogs exhibited, but it must be understood that the Club will not be responsible for loss or injury.
- Dogs must be kept on leash except when in the judging ring.
- There shall be no drilling, intensive or corrective training of dogs on Trial grounds or premises.
- In case of a tie for any prizes, any dog that is not present for a run-off forfeits the right to the prize.
- Entry fees will not be refunded in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, loss of site, or other acts beyond the control of the Club, or if it is impossible to open or to complete the Trial, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to hurricanes, lightning, extreme heat or earthquakes, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the Trial before completion, no refund of entry fees will be made.

- MOVE-UPS (Class Transfers) will be permitted in accordance with Chapter 1, Section 16 of the Obedience Regulations. Please notify the Trial Secretary in writing as soon as possible, but at least 30 minutes prior to judging.
- BITCHES IN SEASON are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than 24 hours prior to the start of the first class, then the Club will refund the entry fee, less a \$10 processing fee, unless the spot can be filled by someone on the wait-list.

### Rules for entering this trial:

1. NO overnight & NO day of show RV parking.
2. NO smoking allowed on the grounds.
3. You will not be allowed to leave your vehicle idling in the parking area.
4. When entering the building you will enter and exit through the side door.
5. Collars must be in accordance with AKC Board Policy, July 2001 (No Electronic Collars)
6. There shall be no drilling, intensive or corrective training of dogs on Trial grounds or premises
7. Crating: Outdoors on grass. NO Stakes allowed. Wire/metal crates are encouraged for safety and ventilation. Mesh crate must be completely zipped closed while dog is inside.
8. Dogs that escape from crate or are uncontrolled must be removed from the show site.
9. Please keep dogs quiet, if barking cannot be controlled you will be asked to leave. Keep dogs on leash while not exhibiting.
10. EXHIBITORS RESPONSIBLE FOR CLEANING UP AFTER THEIR DOGS. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Disposal sites will be available at various locations around the show grounds.

### **Covid 19 – best practices:**

DO NOT COME IF YOU FEEL SICK!!! (If the club is able to fill your entries from the wait-list, your entry fees will be refunded.) DO NOT COME if you have been exposed to anyone with COVID within the 14 days prior to this trial!

1. Participants are required to follow state, local, and facility guidelines that are in effect at the time of the event.
2. You will be required to wear a mask (face covering) while at the show site. You may not enter the building if you are not wearing a mask. You must bring your own mask!
3. For parking – leave at least a vehicle space between your vehicles. There is plenty of parking.
4. Practice social distancing consistent with current guidelines. Avoid congregating to the extent possible.
5. Wear masks when in close proximity to others.
6. If you utilize the bathroom, wear a mask and wash your hands before and after you enter.
7. Avoid shaking hands or hugging.
8. Avoid touching dogs that are not your responsibility.
9. Avoid common use of pens/pencils – bring your own.
