Leo Leis was applying for an Ag Building Variance. A motion was made and seconded to approve the variance up to 6 feet on the town setback from Antony Road. The motion carried.

ATV/UTV committee meeting on county roads was on Monday, May 6th. Dan attended the meeting. Dan presented a draft ATV/UTV ordinance for the town to review. Motion was made to table it until next month.

A motion was made and seconded to approve the liquor license renewal for The Likelee Spot, Inc. The motion carried. A motion was made and seconded to approve the liquor license renewal for Leo's and Leona's, Inc. The motion carried.

Miscellaneous correspondence was reviewed. Our dumpster attendant, Preston Mangan's last day was April 29th. We have three people filling the position. They are Pat Slattery, Steve Kneifl, and Mike Lilla. New dumpster hours are 2 p.m. to 6 p.m. starting in May.
