President's Report

Currently in DC our Lobbyist are following three (3) bills:

- 1. SB 1593 (K. Harris) Pretrial Safety Act. This bill is looking at doing away with bail on the Federal level. PORAC has taken a watch position on this bill.
- 2. SB 1280: Safer Officer & Citizens Act of 2017. The bill is designed to keep officers and communities safer by making grants available to purchase body worn cameras for state, local and tribal law enforcement officers. PORAC active support.
- SB 1258 (C. Booker) Pride Act: Require States to report to the AG's Office certain information regarding use of force incidents involving law enforcement. PORAC is taking a watch position.

### Legislature Report

AB 42 (Bonta) Bail pretrial release: PORAC Active Oppose

AB 20 (Hertzberg) Bail Pretrial release PORAC Active Oppose

AB 748 (Ting) Body Cam Policy: The original form of this bill simply mandated that each agency create a body cam policy and make said policy public. Upon the bills arrival to the Senate Public Safety Committee, several groups (i.e. Public Defenders Association, California Attorneys for Criminal Justice and the California Newspaper Publishers Association) got ahold of the bill and proposed significant amendments. These amendments will make changes to the California Public Records Act. These groups propose creating a deadline of 120 days for the release of all video, regardless of whether there is still an active, ongoing investigation, disallowing the use of redaction technology to obscure specific portions of a recording for law enforcement purposes and prohibiting the use of biometric technology on a video. PORAC will "Active Oppose" this bill if these amendments are not removed.

#### PORAC DC Fly-In Topics

### **Funding Initiatives**

Byrne-JAG: Grants that support Law enforcement and important programs such as: Crime prevention and education.

COPS: Grants that support technical training of law enforcement officers and hiring of new officers.

HIDTA: Grants that provide assistance to law enforcement in critical drug trafficking zones, which provides resources and participation in information sharing.

BWC Pilot Program: Grants funding to local and tribal law enforcement agency to expand the use of body-worn cameras and explore their impact. Issues discussed:

- Federal efforts to combat Gangs and Gang violence. We discussed the violence; crime and drug dealing these groups are involved in and how they pose a major threat to our society. To effectively root out these groups, the federal government must work closely with state and local law enforcement agencies to fund effective, evidence-based gang reduction programs.
- 2. Federal efforts to combat Opioid Epidemic. We discussed that over the past several years, opioid use and abuse has increased dramatically across the country to the point where drug overdoses are now the leading cause of death for Americans under 50.
- 3. Reasonable reforms to Privacy Legislation (ECPA).

Over the two days, our region held over fourteen (14) meetings with various members of the House and Senate.
