**RESOLUTION NO.: SL - 30 - 2023**

**TITLE: Approval For Dr. Sudeep Chandra To Produce A Report Detailing The Water Quality Required By The LCT Population In Summit Lake To Meet The Cultural Needs Of The Summit Lake Paiute Tribe**

**WHEREAS,** the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

**WHEREAS,** the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

**WHEREAS,** the Summit Lake Paiute Tribe is committed to the conservation of cultural and natural resources within the Summit Lake Indian Reservation ("Reservation") and to the long-term protection, preservation, and management of these resources; and

**WHEREAS,** the Summit Lake Paiute Tribe currently administers a Bureau of Reclamation (BOR) grant (R11AV20023) to support the planning and completion of restoration efforts at Summit Lake; and

**WHEREAS,** BOR approved for the Summit Lake Paiute Tribe to contract with an aquatic ecology/biology consultant to produce a report detailing the water quality needed in Summit Lake to ensure the LCT population meets the cultural needs of the Summit Lake Paiute Tribe; and

**WHEREAS,** Dr. Sudeep Chandra possesses the skills to perform the above referenced work, provided a detailed scope of work that meets the specified budget, and anticipates completing the work by the end date of the BOR grant; and

**NOW THEREFORE BE IT RESOLVED** that the Summit Lake Paiute Council hereby authorizes, approves, and consents to entering into an Agreement with Dr. Sudeep Chandra;

**BE IT FURTHER RESOLVED** that the Summit Lake Paiute Council hereby authorizes Tribal Chairwoman to execute the agreement with Dr. Sudeep Chandra and any other instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
