### Course Description:

This **Non-Language Specific** Three (3) credit hour, **Non-Instructor led course**, will familiarize today's Interpreter with common terms and meanings associated with traumatic injury terminology as it pertains to criminal and accidental death investigations. **"Stippling", "Rigor", "Thermal Burns", "GSW"** and other terms and phrases specific to criminal investigations, courtroom proceedings and medical procedures will be highlighted as part of this course. Through a combination of provided video resources, self-guided terminology exploration, definition/word matching and photo/term matching, the language professional can expect to gain a better understanding of terminology and phrases commonly and not so commonly used in today's courtrooms. Explanation of terms which regularly cause confusion due to the rarity of use and/or double meanings due to occupational slang variants are showcased in this block of instruction.
