Subject: Your X Post on Legislation to Overhaul Outdated Defense Acquisition Processes

Dear Hon. Chairman Rogers:



This is a second request with recommendations to improve program management, remove barriers to entry for nontraditional contractors, and enable a digital engineering (DE) ecosystem. Please include them in your legislation to overhaul outdated acquisition processes. The overhaul should include statutes to eliminate the DFARS Earned Value Management System (EVMS) clause and to upgrade requirements for program and project management to be in accordance with standards accredited by the American National Standards Institute. This augments my letter, Subj: Your Opinion on "Future of U.S. Defense" and Comments at U.S. Space Force Celebration, dated January 11, 2025.

Your actions can complete unfinished acquisition reforms that I initiated with Henry Waxman, Ike Skelton, and John McCain. Heidi Shyu incorporated my recommendations to integrate program management with DE in DoD Instructions and guides. However, statutory authorization is needed to overcome the NDIA Integrated Program Management Division's efforts to maintain the status quo by opposing fixes to its EVMS EIA-748 guidelines. Buy a Product that Works, not a SOW.
