"Commercial Home Use" Created for owner occupied properties with current Home Use Exemptions and with multiple units and/or other uses including residential, vacation rental, commercial and industrial. This class includes those properties that have additional units which are left unoccupied or utilized by family members who do not have additional home exemptions or registered long-term affordable leases.
