- Director Goddard will take over project since Director Swanson is resigning from the Board.
- Director Goddard will get pictures of the esplanades to pick the best ground cover.
- Director Swanson reported he flowers have been spread out and the entrances look much better.

• She is still concerned about the bushes on the NW corner of the entrance with look very sparce compared to the rest of the bushes.

# **SECURITY COMMITTEE-**

- Director Gresley reported that SEAL sent her the report that day. She will review and distribute to the Board.
- Mr. Chris Culberson posted on a social site about a vagrant who jumped the fence and into the apartments which made it very clear the problem is at Fleetwood West and not at Fleetwood POA.

# **WALLS, ALLEYS, SEWERS, AND LIGHTS:**

- Director Swanson reported there is a blue "V" painted on the wall, she is not sure if it is
  a City of Houston marking of a utility line or if it is graffiti.
- The Memorial wall repair has been completed but there are complaints about the color of the brick not matching. There is also a leaning issue happening due to the homeowner putting his flowerbed dirt and irrigation system back up against the fence. The Board spoke with vendor Ken Evans who explained he is currently searching for a brick the better matches the wall. He stated he will take down the portion of the wall repaired and redo it with the new brick. This will be done at no additional expense to the association.
