VISITOR CONCERNS AND STATEMENTS County Commissioner Kam Washburn	County Commissioner Kam Washburn reported on recent activities and actions taken by the County Commissioners. Washburn clarified for Bunn that Speedway gas station located at the corner of Scott Road and M-21 in St. Johns requested there be a rezoning at that location, with the intent to expand. There has been no additional activity since the County Commissioners granted that rezoning.
	Jim Graham from Greenbush Township has been appointed to the County's Parks and Greenspace Commission.
	The Commissioners have approved a final plan submitted by Nathan Beck for his trailer building business, located on the corner of Hyde Road and US-27. The proposed plan will bring Beck's buildings into compliance with state and county zoning.
	Washburn reported the Commissioners have approved apportionments for the County. The county's taxable value is \$2,470,000,000, which is about a 1% increase from last year.
	Two new Commissioners will take office January 1, 2015; Ann Hill and Ken Mitchell.

The field in Motz Park (located south of the water on the west side of DeWitt Road) has been enrolled in the Conservation Reserve Program (CRP) for 15 years. There will be a walking trail around the perimeter of the field. Jim Miller, Les Miller & Jim Miller of Les Miller and Sons Aggregates presented a site plan Sons Aggregates for a proposed 20 acre expansion to their operation located at 7250 North Forest Hill Road. Miller asked that the Board recommend approval of the expansion. Greg Armbrustmacher, Greg Armbrustmacher presented a plan to advertise to amend the Maple Rapids Lumber Mill original 1973 Special Use Permit for the Maple Rapids Lumber Mill. The Mill would like to expand 120', to build an office building. Armbrustmacher and Mill owner Ken Grubaugh asked the Board recommend the approval of the amendment. Election and election audit	Bunn said the November General Election ran smoothly. The Township was audited for the November election, and the audit went well, with no significant findings. Bunn reported there were two issues found during the audit, but both were minor and will be corrected in future elections.
	George motioned to approve the Clerk's report, supported by Ferguson. MPC.
SUPERVISOR'S REPORT Planning and Zoning	The Board discussed developing a local Planning and Zoning Commission. There was question as to whether the County would continue to provide inspection services, etc. Kam Washburn would like to discuss with the County Commissioners the role of the County if Townships choose to implement local zoning ordinances. The Board tabled the issue pending further investigation.
