

TOLLESBORO LIONS CLUB, 2021: THE YEAR IN REVIEW



TOLLESBORO LIONS CLUB STILL ACTIVE, APRIL MEETING AND ELECTION OF OFFICERS



The Tollesboro Lions Club had their regular meeting Monday, April 12th at the Tollesboro Lions Club Clubhouse. The meeting was opened by President Lee Thomas with Prayer and the Pledge of Allegiance. Following the prayer and pledge, the members were treated with a dinner served by Skeeter and Sonia Shaw before opening the meeting for business.

Secretary Phil Cropper read the minutes from the last meeting. The minutes referenced that grant monies hat the Club has received from the Kentucky Department of Agriculture, Division of Fairs would be expended to build a new elevated announcer's booth at the site of the Demolition Derby/Mud Sling Track and that an addition was planned that would nearly double the size of the existing elevated announcer's booth located between the Tug Pull and Speed Pull tracks (the main purpose of which is to place the stairs to the upper level within the interior of the building, as well as to add storage areas for concession materials). Blacktop improvements would also be made to the fairgrounds, and both the announcer's booths and blacktop improvements would be made before this year's Tollesboro Lions Club Fair. A nominating committee had been established consisting of Darrel Dixon, Denny Hornback, Larry Tucker, and Jeff Huff which would report their recommendations for 2021-2022 officers at the next meeting. The Kentucky Lions Club Annual Convention would be held remotely this year and the Tollesboro Lions Club was entitled to 3 delegates; the Tollesboro Lions Club would be represented by Lee Thomas, Steven Pedersen, and Craig Stanfield who would serve as delegates. A \$250 donation was approved to the Kentucky Lions Eye Foundation. The minutes were approved as read.

In the absence of the Treasurer, no Treasurer's report was presented.

President Lee Thomas reported that the Shepherd's Church Of God has used the pavilion on the fairgrounds April 3rd. At the same time, a Baby Shower was held on the grounds. A representative of the church called President Lee Thomas to inform the Club that the Baby Shower had left a bag of trash on the grounds. It was suggested that the Club charge a \$50 refundable deposit for the use of the

grounds in order to insure that trash was properly disposed of. A motion was made, seconded and approved.

Under old business, a preliminary fair schedule was presented to the club. NOTE: The next day, Tuesday, April 13th, Craig Stanfield confirmed that the Pony & Mule Pullers Association would be present on Thursday, July 22nd, 7:00 pm.

Continuing under old business, the Nominating Committee made it's recommendations to the Club for 2021-2022 Officers. A motion was made to suspend further nominations and to accept the recommendations of the Nominating Committee. The motion was seconded, and with no further discussion, the motion was voted on and passed unanimously. The 2021-2022 officers elected are as follows: President Craig A Stanfield, First Vice President Clinton Applegate, Second Vice President Lee Thomas, Third Vice President Jim Meadows, Secretary Phil Cropper, Treasurer Steven Pedersen, Tail Twisted Charlie Kendall, Lion Tamer David Hampton, 1 Year Directors Denny Hornback and Daymond Thomas, 2 Year Directors Paul Hampton and Mike Setters.

Under new business: Craig Stanfield reported that he had been contacted by HistoryInYourOwnBackyard about sponsoring a short documentary film about the Cabin Creek Covered Bridge (made ever so important following the destruction by fire --- thought to be arson --- of Washington County's Mt. Zion Covered Bridge last month). Craig committed to see that the video would be made, and reached out to other local businesses about co-sponsorships. Craig was successful in obtaining a number of cosponsors and in reaching out to these co-sponsors, informed them as a condition of their sponsorship that the Tollesboro Lions Club would be considered a co-sponsor at no cost to the club, using the project as a community outreach/community support project. Co-sponsors agreed to this arrangement. To date, Rip's Farm Center, L & L Auto Center, Craig A. Stanfield Real Estate & Auction Services, and Jackie's Deer Lures have agreed to sponsor the creation of the documentary. In contacting other potential sponsors, it was discovered that Fleming County's Covered Bridges had not been sponsored and messages left by the documentary producer had gone unanswered; Craig contacted the production company about the possibility of combining sites in Lewis and Fleming Counties (as the more sites filmed, the lower the overall cost per site), to include 5 to 7 sites all of which would be co-sponsored and would include all of the sponsors including the Tollesboro Lions Club (if 5 sites were committed, Fleming County would add their 3 covered bridges, Goddard, Ringos Mills and Hillsboro and Lewis County would add Tollesboro and it's connections to thoroughbred horse racing as the birthplace of Lucille Parker Wright Markey, who became the owner of Calumet Farm and who's estate formed the basis of the creation of the Markey Cancer Center in Lexington; if 6 or 7 sites were committed, Lewis County would add the Lewis County Courthouse/Soldier's Monument in Vanceburg and Fleming County would add another site or two to the project); the production company agreed to

a joint venture between the two counties. Thus additional sponsors are sought to increase the scope of the project.

The Club was informed that two sets of used aluminum bleachers were available for purchase within the area. A motion was made to attempt to purchase these bleachers for placement on the grounds. NOTE: The next day, Tuesday, April 13th, Treasurer Steven Pedersen viewed these bleachers and made a deal to purchase them.

The Spring Trade Days and a Spring Tug Tractor Pull was discussed. The event is planned for April 30th through May 2nd. The Lions Club plans to host a Tug Tractor Pull April 30th and May 1st.

Being no further business, the meeting adjourned.

TOLLESBORO LIONS CLUB TO RECEIVE GRANT FOR PLAYGROUND RESURFACING

April 20, 2021 - At the April meeting of the Buffalo Trace Area Development District (BTADD) Board of Directors meeting (Tollesboro Lions Club member/2021-2022 President-elect is a member of the Board of Directors, representing Lewis County since August of 1998 and was present at said meeting) under Staff Reports, Planning and Development Department projects, it was disclosed that the Lewis County Fiscal Court has applied for a Community Development Block Grant in the amount of \$70,590 for a pour-in-place cushioned surface for placement at the Playground at the Tollesboro Lions Club Fairgrounds (this is like that installed at the Garrison Playground).

TOLLESBORO LIONS CLUB SPRING TUG TRACTOR PULL IS HUGE EVENT!!!

The Tollesboro Lions Club hosted a Spring Tug Tractor Pull on Saturday, May 2nd. The event started at 1:00 pm in the afternoon and a winner was FINALLY crowned at 10:00 am Sunday morning!!! The event was huge with over 150 participants entered to test their tractor's work capabilities! Both men and women took turns at the wheel of the various tractors. Tractor brands included Ford, International Harvester/Farmall, Allis Chalmers, John Deere, Oliver, Duetz, and more!!!

The event was run a little different as tractor tug pulls have evolved. The pull included tractors weighing from 3500 to 9,000 lbs., with 3500 to 6000 lb. tractors competing for percentage (weight pulled versus weight of tractor), 6000 lb. tractors competing in a middle-weight class, with a 7500 jackpot class, with tractors weighing between 6000 and 9000 lbs. competing for heavy load. The sled started out weighing 4500 lbs., and 1500 lbs. was added to the sled after each heat (until the end of the event when only 1,000 lbs. was added), and at the end of the event had been weighed up to 19,500 lbs.!!! Tractors made use of the entire

track (rather than a 100' length), no side boundary widths (no out of bounds as long as the participants stayed on the dirt and out of the grass). Crowds came and went as the event started in the afternoon and extended throughout the evening and into the morning hours, with the person's on the grounds at the end of the event not only seeing the sun come up but getting reaching rather high in the sky at the event's eventual end!

TOLLESBORO LIONS CLUB HOSTS MAY MEETING

The Tollesboro Lions Club hosted their regular meeting May 10, 2021 at the Tollesboro Lions Club Clubhouse on the Tollesboro Lions Club Fairgrounds with President Lee Thomas presiding and opening the meeting. After Prayer and the Pledge of Allegiance, the members enjoyed a meal. Following the meal, the first item of business was the Secretary's report. Secretary Phil Cropper reported the minutes of the last meeting, April 26th. The meeting was attended by two guests from the Orangeburg Lions Club, Lion Don Toller and Lion David Frye. They reported on their Club's activities and inquired as to use of the Tollesboro Lions Club Fairgrounds for a Car Show. A motion was made and approved for the Orangeburg Lions Club to use the grounds for a Car Show at a future date to be determined, with the Orangeburg Lions Club to report back to the Tollesboro Lions Club the date to insure that the event would not interfere with any Tollesboro Lions Club event. Next, he reported that construction was going to begin the next day (May 11th, 2021) on the new elevated announcer's booth to be located at the Demolition Derby/Mud Sling Pit and the planned expansion of the existing elevated announcer's booth located between the Tug Pull and Speed Pull Tracks and informed the members present that their assistance would be needed following the meeting for a short Work Night so as to remove items from the existing announcer's booth to permit the construction to proceed unimpeded. It was also reported that the blacktopping project had been completed with the main road improved substantially including parking areas along the playground and by the concession stand, with a significant portion of the walking track improved as well (extending from the playground to the Clubhouse. It was noted that, even though the weather was cool, an organized group of children were using the ballfield that evening, with several children using the playground as well. Next it was reported that the Summer Trade Days was scheduled for Friday June 18th through Sunday, June 20th. TOLLESBORO LIONS CLUB COMMUNITY PARK BALLFIELD

Tollesboro Lions Club Recipient of Grant to Improve Playground

The Lewis County Fiscal Court has successfully applied for a Crumb Rubber Grant to improve the Tollesboro Lions Club Playground! The grant was announced in a communication to the Lewis County Judge Executive Jimmy Lykins by letter from the Energy and Environment Cabinet for Environmental Protection, said letter dated May 14, 2021.

This grant will provided a poured-in place surface made from recycled tires on the surface of the playground to create a safe barrier for children to prevent injuries in the event of a fall or tumble. This will replace the current chipped tire mulch currently in use, and is a significant improvement. The grant is for \$70,590 requiring a 25 percent match (in-kind labor to remove the existing surface will count towards the grant contribution).

The Tollesboro Lions Club looks forward to this improvement being made and offers it's sincere thanks to the Cabinet, the County Judge, the Fiscal Court, and the Buffalo Trace Area Development District for their work in acquiring this grant!

Congratulations on submitting a successful application for a Waste Tire Crumb Rubber/Tire Derived Products Grant proposing a project that utilizes Kentucky waste tires! The Energy and Environment Cabinet is looking forward to providing funding in the amount of **\$70,590** for your project. Please take a moment to review the required conditions for grant funding.

- The recipient must sign a written agreement stating the terms and conditions of the grant and indicating the recipient agrees to complete the crumb rubber grant project for landscaping, paths or poured-in-place surfacing as defined in the agreement. Please review all requirements in the agreement, which is attached.
- The grantee must provide a 25% match. The 25% match may be through in-kind contributions, meaning the value of non-cash contributions provided by parties. In-kind contributions may be in the form of real property, equipment, supplies, and other expendable property, and the value of goods and services directly benefiting and specifically identifiable to the project.
- Beginning with this grant cycle, deadline extensions will not be routinely granted. You are encouraged to begin your project early in the grant cycle to avoid weather related delays.

The grant funding is to be used for costs associated with the purchase of the crumb rubber as specified in your grant application.

The Tollesboro Lions Club recently made substantial improvements to their fairgrounds. In 2021, the Club has provided infrastructure improvements to their most recently acquired adjoining acreage (electrical upgrades, new lighting, waterline extensions, fencing, clearing and leveling of the acreage, new culvert and gravel roadway extensions/improvements, and more). In addition, the Club has erected additional permanent bleacher seating at the Demolition Derby/Mud Sling Pit and constructed a new elevated announcer's booth at this location. In addition, the existing elevated announcer's booth situated between the Tug Tractor Pull Track and the Speed Event Track has been added onto to double it's size while placing the stairway (formerly located on the outside of the building) in the building's interior (this was a needed improvement as weather has impacted the wooden stairway structure requiring it to be replaced. By placing this stairway in the interior, the stairway should last for decades!). In addition, blacktopping has been performed to improve roadways as well as portions of the walking track, and to provide parking areas alongside the concession stand and the playground.





Livestock Show Rules

- The show is open to bonafide 4-H and FFA members until they age out in their respective programs. 4-H members must qualify by completing the 6 hour meeting policy by the tag in dates.
- All 4-H, FFA entries must be nominated and identified with tag numbers.
- The Show is a blow & go show only, no use of adhesives, camouflaging agents, no use of dyes or other coloring agents to camouflage the natural coloring of an animal. The use of false tailtead or switches will be prohibited. Animals may be disqualified at the discretion of the judge or the rules committee.
- All sheep and goats must be scrapies tagged.
- Questions on rules will be referred to the rules committee in charge. Their decision is final. A protest must be made prior to show. Protesters must pay a \$100 non-refundable fee. DNA sampling can be fanned at the discretion of the rules committee at anytime.
- Any action by participants, guardians or parent not in the best interest of the show will result in automatic disqualification from the show.
- No using of ice, no beating, and no injection of fluids in any way to animals.
- Exhibitors must follow the KY 4-H & FFA ownership and possession rule and have a signed form on file with their agent or advisor.
- Showmanship will be determined by age as of Jan. 1, 2015. Senior showmanship classes will be ages 14 and older, Junior showmanship classes will be ages 9-13, and Novice showmanship classes will be ages 8 and under.

Steers

- Steers must be halter broken and must be tied in stalls with neck ropes.
- Only steers are eligible. Steers must be dehorned before weigh-in.
- Steers must weigh 850-1450 lbs. at the time of show.

Feeder Calves

- Calves may be any beef breed without any daily influence.
- Calves must be born January 1- March 31, 2015.
- At fair time calves must weigh a minimum of 300 pounds and a maximum of 700 pounds.

Hogs

- Hogs will be driven.
- Barrows and gilts are eligible.
- Hogs must weigh between 200-280 lbs. Animals under this weight will be placed in an under weight class and those over will be placed in an overweight class.

Lambs

- Lambs can be shown with or without halters.
- Ewes and wethers are eligible.
- Lambs must weigh at least 80 pounds and have their lamb teeth at show time Any lambs under 80 lbs. will all be put in one class designate 79 lbs. and under.
- No unshorn lambs; they also must be docked and fitted.

Goats

- Horns are optional, but must be tipped. Tipped is defined as the end of the horn squared off to 1/2 inch in diameter or larger.
- All goats are required to have a complete unbroken mouth and goat teeth and weigh a minimum of 40 pounds at the fair. Any animals underweight will all be placed in a class designated 39 lbs, and under. Animals are subject to be mouthed to check age.
- Goats will be shown by weights.
- Market kids must be clean castrated (banded or surgically removed, clamping is not allowed), and the animal must be clipped slick above the knee and hock joint (5/8 inch or less). No artificial color may be used.
- Exhibitors may enter market wethers or market does. Induced cryptorchids (short scrotum kids) and buck goats may not be shown. Any wether kid showing signs of secondary sexual characteristics may not be shown.

302 KAR 20:040. Entry into Kentucky

RELATES TO: KRS Chapter 257, 9 C.F.R. Chapter 1 parts 77, 78

STATUTORY AUTHORITY: KRS 246.295, 257.030, 257.070, 257.550

NECESSITY, FUNCTION, AND CONFORMITY: KRS 257.070 requires that importation of animals into Kentucky complies with administrative regulations promulgated by the board. KRS 257.030 authorizes the board to establish necessary quarantines and other measures to control the movement of animals into, through, or within Kentucky. This administrative regulation establishes health requirements for entry, including entry for sales or exhibition, for livestock and animals into Kentucky.

Section 1. General Provisions. (1) All animals entering Kentucky shall be subject to the requirements established in 302 KAR 20:020.

(2) All animals shall be accompanied by a Certificate of Veterinary Inspection (CVI) or other official movement document except for exemptions listed under each species section of this administrative regulation or 302 KAR 20:065. Examples of an official movement document shall include a way bill with a permit number or Federal Movement Form VS 9-3 or VS 1-27.

(3) If an entry permit is required by this administrative regulation, it shall be obtained by calling OSV at (502) 564-3956, Monday through Friday, 8 AM EST to 4:30 PM EST. The permit number shall be recorded on the CVI or other required species specific document obtained pursuant to subsection (2) of this section.

(4) If the state veterinarian determines based on an epidemiological evaluation of current disease risks that additional requirements are needed to prevent the introduction or spread of disease, the OSV shall direct a person to comply with the additional entry requirements. The notification of additional requirements shall be written or given orally and confirmed in writing.

(5) All required tests shall be conducted by a state-federal approved laboratory as defined by 9 C.F.R. Chapter 1.

(6) A CVI for entry shall:

- Be valid for thirty (30) days from the date of issue;
- Become void upon arrival at the designated destination, except for exhibition animals which may return home within thirty (30) days of the original issue date; and
- State a valid destination address or PIN.

Section 2. Cattle or Other Bovine Species. (1) General requirements for entry.

(a) Cattle or other bovine species for exhibition, breeding, or feeding purposes, or for sale purposes except as defined in paragraph (b) of this subsection shall meet the requirements established in subsections (2) and (3) of this section.

(b) Cattle or other bovine species imported directly to a recognized slaughter center or a state-federal approved stockyard shall meet the requirements established in subsections (3) and (4) of this section.

(c) Cattle or other bovine species imported to a Kentucky premises from an out of state federally approved livestock market shall meet the requirements established in subsections (3) and (4)(d) of this section.

(2) Certificate of Veterinary Inspection and Entry Permit.

(a) All cattle or other bovine species entering the state for sale, exhibition, breeding, or feeding purposes shall be accompanied by a valid CVI as required by 302 KAR 20:020, Section 1(3)(c).

(b) An entry permit shall be required prior to entry for all cattle or other bovine species except steers, spayed heifers, cattle or other bovine species presented for exhibition only. The permit number shall be recorded on the CVI.

(3) Specific diseases.

(a) Brucellosis.

- The importation of cattle or other bovine species shall comply with 9 C.F.R. Part 78.
- Animals from class free states shall be exempt from testing.
- Animals originating from a brucellosis certified herd shall be exempt from testing. The herd certification number and date of last herd test shall be indicated on the CVI.

(b) Tuberculosis.

- The importation of cattle or bison shall comply with 9 C.F.R. Part 77.
- Animals from class free states shall be exempt from testing.
- Animals originating from a tuberculosis accredited herd shall be exempt from testing. The herd accreditation number and date of last herd test shall be indicated on the CVI.

(c) Scabies. Cattle or other bovine species affected with or exposed to scabies or from an area quarantined because of scabies shall not be eligible for entry into Kentucky except:

- In accordance with 9 C.F.R. Part 73 of the USDA APHIS VS; and
- If a written permit from the State Veterinarian or an authorized representative is obtained pursuant to 9 C.F.R. Part 73.

(d) Ticks. Cattle or other bovine species from a state-federal tick quarantined area, as defined by 9 C.F.R. Part 72, shall not be eligible for entry into Kentucky except:

- In accordance with 9 C.F.R. Part 72 of the USDA APHIS VS; and
- If a written permit from the State Veterinarian or an authorized representative is obtained pursuant to 9 C.F.R. Part 72.

(e) Johne's Disease. The importation of cattle or other bovine species shall comply with 9 C.F.R. Part 80.

(4) Other movements.

(a) If cattle or other bovine species from a brucellosis class-free state that is also a tuberculosis class-free state move directly from a farm of origin, they may enter a state-federal approved stockyard in Kentucky without an entry permit or CVI. Those cattle or other bovine species shall meet the requirements established in paragraph (c) of this subsection.

(b) Slaughterer cattle or other bovine species. Cattle or other bovine species consigned for immediate slaughter may enter Kentucky without an official test for brucellosis or tuberculosis if the cattle or other bovine species are consigned for immediate slaughter to a recognized slaughtering center or to an approved state-federal stockyard as defined by 9 C.F.R. Part 71, for reconsignment to a recognized slaughtering center. Animals diverted en route shall be in violation of this administrative regulation.

(c) The seller's name and address and either the animal's premises of origin or PIN shall be provided for cattle or other bovine species imported to a state-federal approved stockyard or directly to a recognized slaughtering center.

(d) Cattle or other bovine species moving from an out of state state-federal approved stockyard shall be accompanied by a bill of sale or way bill.

Section 3. Horses or Other Equine Species. (1) General requirements for entry.

(a) All horses or other equidae entering Kentucky for any purpose, except as provided in paragraph (b), (d), and (e) of this subsection, shall meet the requirements established in subsections (2) and (3) of this section.

(b) Equine purchased by a licensed Kentucky dealer at an out-of-state horse sale shall:

- Enter the state on an entry permit;
- Be accompanied by a VS Form 10-11 or EIA test form verifying a negative equine infectious anemia (EIA) test within the last twelve (12) months or shall be tested for EIA within two (2) weeks of entry; or
- Move directly to an approved Kentucky horse sale.

(c) Equine entering the state for racing purposes shall meet the requirements established in KAR Titles 810 and 811.

(d) Equine moving directly to a veterinary facility in Kentucky shall be exempt from subsections (2) and (3) of this section.

(e) Equine may be moved directly to an approved Kentucky horse sale by an out of state, nondealer owner

from that owner's premises.

(2) Certificate of Veterinary Inspection.

(a) A CVI shall be required for equine entering the state except as provided in subsection (1)(b) and (d) of this section and shall meet the criteria established in 302 KAR 20:020, Section 1(3)(c).

(b) Equine Interstate Event Permits from states participating with Kentucky shall:

1. Be accepted for exhibition purposes in lieu of the CVI and EIA test report if they are within six (6) months of the issue date and there has been no change of ownership; and
2. Meet the requirements established in 302 KAR 20:020, Section 1(5).

(3) Equine infectious anemia.

(a) All horses or other equidae, except unweaned foals accompanied by their dam, shall be negative to a USDA official test, pursuant to 9 C.F.R. Part 75, within twelve (12) months prior to entry.

(b) A copy of the Form VS 10-11 or EIA test form verifying a negative EIA from a laboratory approved by the USDA, pursuant to 9 C.F.R. Part 75, shall be attached to the CVI.

(4) Approved Kentucky horse sales.

(a) Horses or other equidae purchased by a licensed Kentucky dealer out-of-state may move directly to an approved Kentucky horse sale without proof of a negative EIA test.

(b) All horses or other equidae presented without proof of a negative EIA test within the previous twelve (12) months shall have a blood sample drawn for EIA testing by the market veterinarian approved by the OSV pursuant to 302 KAR 20:261, at the seller's expense.

Section 4. Swine. (1) General requirements for entry.

(a) Except as provided in paragraph (b) of this subsection, domestic swine for exhibition, sale, breeding, or feeding shall meet the requirements established in subsections (2) and (3) of this section.

(b) Swine imported directly to a recognized slaughtering center or a state-federal approved slaughter-only stockyard shall meet the requirements established in subsections (3) and (4) of this section.

(c) Swine imported to a Kentucky premises from an out of state federally approved stockyard shall meet the requirements established in subsections (3) and (4) of this section.

(d) Swine listed in this paragraph shall not be imported for any purpose:

1. Garbage fed swine;

2. Wild, captive wild, or feral swine, *Sus scrofa* per definition, including Russian wild boars or Eurasian wild boars; or

3. Swine vaccinated with Pseudorabies vaccine.

(2) Certificate of Veterinary Inspection and Entry Permit.

(a) All swine entering the state for sale except as provided in subsection (1)(b) and (c) of this section, exhibition, breeding, or feeding purposes shall be accompanied by a valid CVI as required by 302 KAR 20:020, Section 1(3)(c).

(b) An entry permit shall be required prior to entry for all swine entering for sale, breeding, or feeding purposes. An entry permit shall be required for exhibition purposes from states with less than Stage 5 Pseudorabies status. The permit number shall be recorded on the CVI.

(3) Specific diseases.

(a) Brucellosis. The importation of swine shall comply with 9 C.F.R. Part 78.

(b) Pseudorabies. Testing shall not be required for swine imported if the swine originated from a Pseudorabies Stage 5 state. Swine originating from a state with less than Pseudorabies Stage 5 status shall comply with 9 C.F.R. Part 85.

(4) Swine imported to a state-federal approved livestock market, directly to a recognized slaughtering center, or to a Kentucky premises from an out of state federally-approved stockyard shall be identified with:

(a) Official identification in accordance with 302 KAR 20:020, Section 1(2); and

(b) The seller's name and address and either the animal's premises of origin or PIN.

Section 5. Sheep or Lambs. (1) General requirements for entry.

(a) Sheep or lambs for sale except as provided in paragraphs (b) and (d) of this subsection, exhibition, breeding, or feeding purposes shall meet established requirements in subsections (2) and (3) of this section.

(b) Sheep imported directly to a state-federal approved stockyard or a recognized slaughtering center shall meet the requirements established in subsections (3) and (4) of this section.

(c) Sheep or lambs that originate from known trace, source, or infected Scrapie flocks as determined by the USDA APHIS VS in compliance with 9 C.F.R. Part 79 shall not be imported.

(d) Sheep imported to a Kentucky premises from a state-federal approved stockyard shall meet the requirements established in subsections (3) and (4) of this section.

(2) Certificate of Veterinary Inspection and Entry Permit.

(a) All sheep or lambs entering the state for sale except as provided in subsection (1)(b) and (d) of this section, exhibition, breeding, or feeding purposes shall be accompanied by a valid CVI as required by 302 KAR 20:020, Section 1(3)(c).

(b) An entry permit shall be required for sheep or lambs entering for sale, breeding, or feeding purposes.

(3) Specific diseases.

(a) Scrapie.

1. All sheep shall originate from a Scrapie consistent state meeting the requirements of the USDA APHIS VS Scrapie Flock Certification Program established in 9 C.F.R. Part 79.

2. Sheep that require a CVI for movement shall be identified with an official USDA Scrapie Program identification tag or other official identification method and documented on a CVI.

3. If enrolled in the USDA Scrapie Flock Certification Program, the Scrapie Flock number shall be recorded on the CVI.

(b) Scabies. Sheep affected with or exposed to scabies or from an area quarantined because of scabies shall not be eligible for entry into Kentucky.

(c) Sore mouth. Any sheep or lambs showing lesions of contagious ecthyma shall not be imported.

(d) John's. The importation of sheep or lambs shall comply with 9 C.F.R. Part 80.

(4) Other movements.

(a) Sheep or lambs from Scrapie consistent states may be imported into Kentucky for immediate slaughter if consigned directly to a recognized slaughtering center approved by the USDA or the State Veterinarian or to a state-federal approved stockyard or concentration point if reconsignment from that point is to immediate slaughter.

(b) Only sheep or lambs from Scrapie consistent states may be imported to state-federal approved stockyards or state-approved concentration points for the purpose of sale.

(c) VS Form 1-27 shall be required for movement of sheep or lambs from trace, source, or infected flocks to an approved site.

(d) Sheep or lambs imported to state-federal approved stockyards, concentration points or directly to a recognized slaughtering center or to Kentucky premises from a state-federal approved stockyard shall be identified with:

1. An identification in accordance with 9 C.F.R. Part 79; and

2. The seller's name and address and either the animal's premises of origin or PIN.

Section 6. Goats. (1) General requirements for entry.

(a) Goats entering Kentucky for sale except as provided in paragraph (b) of this subsection, exhibition, breeding, or feeding purposes shall meet the requirements established in subsections (2) and (3) of this section.

(b) Goats imported directly to a recognized slaughtering center, a state-federal approved stockyard, telemarketing sale, or KDA approved graded sale shall meet the requirements established in subsections (3) and (4) of this section.

(c) Goats imported to a Kentucky premises from a state-federal approved stockyard shall meet the requirements established in subsections (3) and (4) of this section.

(2) Certificate of Veterinary Inspection and Entry Permit.

(a) All goats entering the state for sale except as provided in subsection (1)(b) and (c) of this section, exhibition, breeding, or feeding purposes shall be accompanied by a valid CVI as required by 302 KAR 20:020, Section 1(3)(d).

(b) An entry permit shall be required for goats entering for sale, breeding, or feeding purposes.

(3) Specific diseases.

(a) Scrapie.

1. All goats shall originate from a Scrapie consistent state meeting the requirements of the USDA APHIS VS Scrapie Flock Certification Program established in 9 C.F.R. Part 79.

2. Goats that require a CVI for movement shall be identified with an official USDA Scrapie Program identification tag or other official animal identification in accordance with 302 KAR 20:020, Section 1(2).

(b) Brucellosis. Animals six (6) months of age or older shall have an official negative test within thirty (30) days prior to entry or originate directly and immediately from a class free state or a brucellosis-certified herd.

(c) Tuberculosis. Animals six (6) months of age or older shall have an official negative tuberculin test within sixty (60) days prior to entry or originate directly and immediately from a class free state or a tuberculosis-accredited herd.

(d) Scabies. Goats affected with or exposed to scabies or from an area quarantined because of scabies shall not be eligible for entry into Kentucky.

(e) John's. The importation of goats shall comply with 9 C.F.R. Part 80.

(4) Goats of any age entering a state-federal approved Kentucky stockyard, KDA-approved graded sale, telemarketing assembly point, a Kentucky recognized slaughtering center, or a Kentucky premises from a state-federal approved stockyard shall be identified with:

(a) An identification in accordance with 9 C.F.R. Part 79; and

(b) The seller's name and address and either the animal's premises of origin or PIN.

Section 7. Poultry, Farm-raised Upland Game Birds or Other Avian Species. (1) General requirements for entry.

(a) Birds four (4) months or older for sale or exhibition purposes shall meet the requirements established in subsections (2) and (3) of this section.

(b) Chicks or hatching eggs imported shall meet the requirements established in subsections (2) and (3)(a)2 of this section.

(c) All birds imported to an approved slaughter facility and all commercial birds moving between a company's production units shall meet the requirements established in subsections (3) and (4) of this section.

(2) Certificate of Veterinary Inspection.

(a) All poultry shall be accompanied by:

a. An NPIP VS Form 9-3 as specified in 9 C.F.R. Part 145 including flock number issued; or

b. A CVI verifying a valid test date.

(3) Specific diseases.

(a) Salmonella pullorum.

1. Birds four (4) months of age or older shall be negative to an official Salmonella pullorum test within thirty (30) days of entry or originate from a NPIP flock. The NPIP flock number or both the test date and the laboratory of test shall be recorded on the CVI.

2. Chicks or hatching eggs shall originate from NPIP flocks or a flock that satisfies the requirements of KRS 257.410.

(b) Avian influenza. All poultry shall comply with the requirements of 302 KAR 20:250, Avian influenza.

(4) Other movements.

(a) Commercial birds moving between company units shall have a way bill or log sheet stating origination of birds and intended destination with flock NPIP number.

(b) Birds going directly to an approved slaughter facility shall provide the name and address for premises of origin.

Section 8. Psittacine or Pet Birds. The entry of psittacine or pet birds shall comply with 9 C.F.R. Part 82.

(1) General requirement for entry.

(a) All psittacine or pet birds imported for any purpose shall meet the requirements established in subsection (2) of this section.

(b) All psittacine or pet birds shall be identified with official identification in accordance with 302 KAR 20:020, Section 1(2).

(c) All importers of psittacine or pet birds for other than exhibition purposes shall keep records that indicate the origin and date of shipment, the name and address of the breeder, the number of birds shipped, and the name and address of the persons to whom the imported birds are sold.

(2) Certificate of Veterinary Inspection. All imported psittacine or pet birds shall be accompanied by a CVI, inspected and found free of infectious and communicable diseases within fifteen (15) days immediately prior to the date of entry.

TOLLESBORO LIONS CLUB FALL HORSE SHOW A GREAT SUCCESS

The Tollesboro Lions Club hosted a Fall Horse Show on the grounds of the Tollesboro Lions Club Saturday evening, September 11th with 30 classes. The event was well received both by the public at large and by the numerous exhibitors.

TOLLESBORO LIONS CLUB HOSTS FUND-RAISERS

In 2021, a number of fund-raisers were conducted at the Tollesboro Lions Club to raise monies for those suffering from illness (in more than one instance) and (at least two events) to assist families who had lost loved ones with funeral expenses and to assist with hospital expenses (one of these events was to benefit a local person whom was killed in an automobile accident - his wife gravely injured - that was not their fault. Another was to assist in the burial of a child). These events consisted of dinners, auctions (silent and live), and Poker Runs using semi-trucks and ATVs. These events were all very successful with several fundraising events generating \$10,000 or more in funds to assist the persons for whom the events were hosted.

TOLLESBORO LIONS CLUB HOSTS ZONE MEETING

The Tollesboro Lions Club hosted a zone meeting Tuesday, October 8th at 6 pm. at the Tollesboro Lions Club Clubhouse. Zone Chairman and Tollesboro Lions Club member Clinton Applegate opened the meeting with five clubs represented by 15 members. Tollesboro Lions Club President Craig Stanfield led the group in the Pledge of Allegiance and Tollesboro Lions Club Treasurer Steve Pedersen offered prayer. The group then enjoyed a wonderful meal prepared by Tollesboro Lions Club member Jim Meadows.

Following the meal, a registration sheet was passed around the room so that the members present could list the members present and the Club they represented. The Tollesboro Lions Club was represented by 4 members (Clinton, Steve, Craig and Anthony Wellman; Jim Meadows, who provided the meal, was not present during the meeting as he was harvesting crops); The Maysville Lions Club was represented by 3 members (Tom and Angela Jett and Pat Steimle); the Orangeburg Lions Club was represented by 5 members (Brittany Robbins, Donald and Mary Toller, and John and Wilda Frye); the Vanceburg Lions Club was represented by 2 members (Roger Brown and Michael Edington) and the Mays Lick Lions Club was represented by Charles Thomas. Each club was asked to discuss the projects that they were able to conduct and which projects that had to be put on hold due to Pandemic restrictions.

The Maysville Lions Club indicated that they were conducting in-person meetings; their main fund-raising project has always been the Lions Club Radio Auction which has been suspended the last two years. The Club is still collecting eyeglasses and assisting individuals in sight preservation and has been conducting vision testing/screenings, and providing scholarships.

The Orangeburg Lions Club has been meeting twice monthly, however attendance has been sharply reduced since the Covid-19 pandemic restrictions were first put in place. They also have had to suspend or greatly reduce the scope of their main fund-raising project, the annual Fall Festival, Auction and Soup Supper as the auction has not been conducted last year or this year, and the fund-raising dinners have been altered from "in-place" to "drive-thru" events and have not had the same success that the organization has had in the past. They too have been assisting individuals with sight preservation and collecting eyeglasses and providing scholarships.

The Vanceburg Lions Club has had to cancel some of their fundraisers, including Heritage Days and the Basketball Tournament. They did raffle a kayak as a fund-raiser. They are collecting eyeglasses, providing eyeglasses for adults, and have sponsored (although not entirely due to decreased revenues) fireworks during the Fourth of July Celebration.

The Mays Lick Lions Club is still meeting, but mostly is meeting to play Euchre. They have not had pancake breakfasts during the Pandemic, and have taken on Trash Collection along roadways through a program offered by the county as a fund-raiser. They had to give up the Mays Lick Streetlight program due to rising costs and decreased income streams.

The Tollesboro Lions Club has been fortunate to be able to host the Tollesboro Lions Club Fair this year; the most successful fair ever, with record attendance each day of the full week due to a perfect storm of great weather coupled with a need and desire of the public to get out and participate after the long restrictions caused by the Pandemic (and

last year, the fair was scaled down substantially, however the Club was able to host a number of weekend fund-raising events that carried the Club through). The organization is continuing to meet twice monthly through most of the Pandemic, exercising social distancing during meetings (however the Club had been hosting only once monthly meetings from November through April each year for several years, resuming to twice monthly in May each year). They are continuing to collect eyeglasses for recycling, bottle caps for benches, are assisting with eyeglasses for the needy, sponsored 4 scholarships annually, and has been fortunate to increase the size of the fairgrounds as well as having made significant improvements to the fairgrounds during the Pandemic due to a number of grants and donations. The Tollesboro Lions Club is planning a Christmas Dinner for members and their spouses this year (after canceling the event last year due to Pandemic restrictions).


Lion Steve Pedersen, Second District Governor, encouraged the clubs to turn in their service hours to Lions International. Most clubs indicated that they had trouble with the automated system which is quite complicated to learn; however the automated system is easy to navigate once you have mastered the system and Lion Pedersen offered to arrange a meeting with the Clubs to show them how to navigate the system and encouraged each Club to set up a Service Chairperson to enter the service hours and a Marketing Communications Chairperson to write articles for submission to Lions Club system and local newspapers.

Each club was also encouraged to reach out to obtain more members. Each club discussed how hard it is to retain membership and reach out to new members ESPECIALLY during the Pandemic. A bright spot is that the local zone is the only zone in the state with no Clubs under probation due to membership declining below 15 members (although 2 clubs within the zone are at the 15 member threshold). All clubs also mentioned that their membership is aging without new younger membership created.

Overall, the meeting was informative and great fellowship and the Clubs were able to share ideas and plans for improvement.

TOLLESBORO LIONS CLUB MAKES IMPROVEMENTS TO PLAYGROUND

The Tollesboro Lions Club was the recipient of a grant to make further improvements to the Tollesboro Lions Club Playground. The playground, which was installed in 2018, now has a new "poured-in place" surface. The placement of the poured in place surface required the removal of the shredded tire mulch, the placement of a new gravel substrate surface (which was compacted and leveled before being covered up), the placement of a perimeter form to hold the new surface in place until it could set up, and the placement of the poured-in place surface. This is a significant improvement, cleaner, safer, with the playground no longer having the mulch moved out due to heavy rains. This improvement was installed at a cost in excess of \$80,000 and the improvement could not have been performed without grant assistance.
